Provide assistive technology and accommodations to support individuals with disabilities and wounded, ill and injured service members throughout the Federal Government in accessing information and communication technology. CAP works with medical providers, therapists, case managers, and military liaisons at military treatment facilities (MTFs) to increase awareness and availability of assistive technology (AT). Once the appropriate AT has been identified, CAP provides the solutions, free of charge, to support a service member's medical recovery and rehabilitation.

Assists individuals with disabilities to select, acquire and use assistive technology to succeed in the workplace and live independently. Examples of AT provided included hand controls for cars, ramps and stair glides for the home, alternative keyboards and mice or screen magnification and screen readers for computers, and specialized computer-based writing tools. Also assist eligible persons with physical, mental or emotional disabilities to get job training and placement and refer to appropriate programs. Office for Blindness & Vision Services provides evaluation and training and case management services to individuals who are blind or visually impaired to help them live and work as independently as possible.
