



## KEMP MILL ESTATES PHASE I SIDEWALK & CURB/GUTTER PROJECT

Silver Spring, MD

### PURPOSE

This letter is to inform you of the upcoming Kemp Mill Estates Phase I sidewalk and curb/gutter repair project from Kemp Mill Road to Lambertson Road. Please see the Project Map located on the reverse side of this newsletter for the locations. This neighborhood preservation project employs long term strategies to improve sidewalk and curb/gutter conditions.



### DRIVEWAY APRON AND LEAD WALK REPAIR PROGRAM

The Driveway Apron and Lead walk Repair Program allows homeowners to take advantage of the county's competitively bid contract prices to repair your existing driveway apron/lead walk. When work begins in your neighborhood, an inspector will evaluate your apron/lead walk to determine if its condition qualifies you to exercise the replacement option. The inspector will then leave instructions at your door.

### SCHEDULE

This project is scheduled to start in September and will take 8-10 weeks to complete, with a chance to be finished next Spring. weather and other operational requirements permitting. Work hours will be between 7am and 7pm, Monday through Friday.

### IMPACTS

The county right-of-way near your residence or business may be disturbed by the planned project improvements. Following the completion of the project all disturbed areas within the county right-of-way will be restored as appropriate.

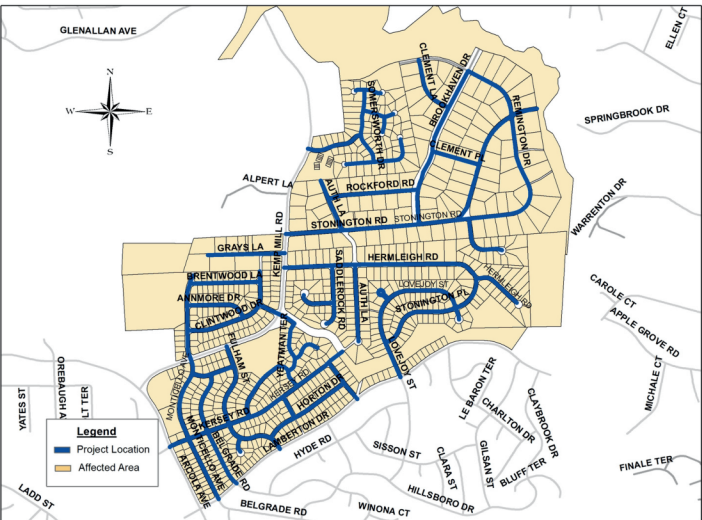

## LAWN SPRINKLER/INVISIBLE DOG FENCE INFORMATION

If your home has either a buried lawn sprinkler system or invisible-type dog fence installed, please make sure that the system DOES NOT extend into the county right-of-way. If it does, please mark the locations of buried pipe or wire so that our equipment can attempt to avoid it. However, such systems are not permitted by the County Code to be located in the right-of-way and neither the County nor its contractors are responsible for any damage to any systems located there. If you do not know the locations, look in your phone book under Utilities, Underground Cable, Pipe and Wire Locating Service.
