1 Overview / General Information

Montgomery County Board of Elections provides Voter Registration Information to Maryland registered voters, updated monthly electronically on a USB Flash Drive or CD as:

- an unsorted flat file, which is updated monthly
- a walking list provided in Adobe Acrobat format (.PDF)
- a district precinct and street level demographic analysis
- mailing labels, in Adobe Acrobat format (.PDF)

The data provided includes voter history for Presidential and Gubernatorial elections.

Please review the Frequently Asked Questions for detailed answers to common questions and problems.

2 Data Use

Data can only be provided to individuals who are registered voters in the State of Maryland. The data provided by the Board of Elections may only be used for election purposes and under no circumstances may be used for commercial solicitation. According to Maryland Election Law Article 3, Section 3-506(a)(1)(ii)(1-2), a person who knowingly allows a list of registered voters, under the person’s control, to be used for any purpose not related to the electoral process is guilty of a misdemeanor. A signed affirmation is required before data can be provided.

3 Data File

One set of data are provided in compact disk format, which includes a complete list of active voters in Montgomery County and voting history from presidential and gubernatorial elections associated with those voters. This file is provided in CSV (Comma Separated Values) format.

The previous ten Presidential and Gubernatorial elections are included for all voters. This includes both primaries as well as general elections. For example:

- 2) 2012 Presidential General Election
- 3) 2014 Gubernatorial Primary Election
- 4) 2014 Gubernatorial General Election
- 5) 2016 Presidential Primary Election
- 6) 2016 Presidential General Election
- 7) 2018 Gubernatorial Primary Election
- 8) 2018 Gubernatorial General Election
- 9) 2020 Presidential Primary Election
- 10) 2020 Presidential General Election

Descriptive field names such as “09/14/2010-GP” are appended to the end of the record to provide voting history. Each field is either blank, indicating the voter did not vote in that election, or a description of the election appears in the field such as “GUBERNATORIAL PRIMARY – 2010”.

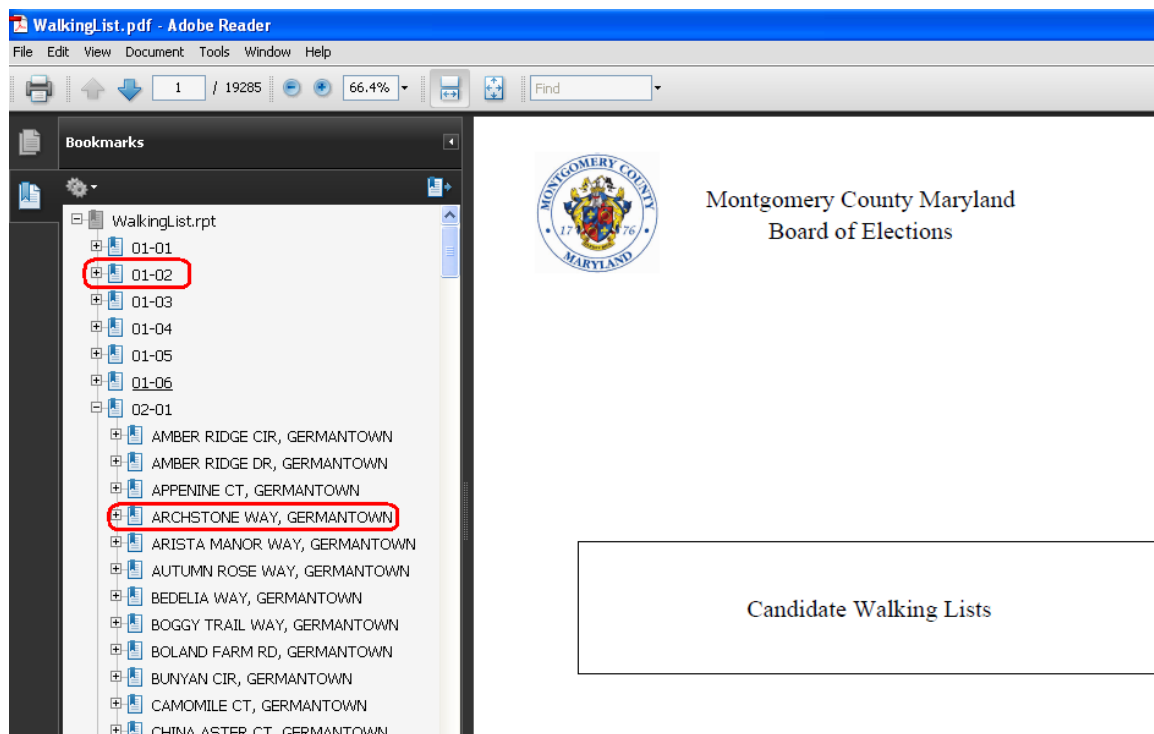

4 Walking List

A walking list appears on the CD or USB Flash Drive as “WalkingList.pdf” in Adobe Acrobat format (PDF). Due to the size of the file, it is recommended that the file be copied to a local drive and not accessed directly from the CD.

The bookmarks on the left side of the screen allow you to navigate by district precinct and by street name. In the example below district precincts are listed in order. The bookmark 01-02 contains all of the streets with voters in that district precinct. By clicking on the + next to a specific district precinct the streets in that district precinct are listed. In the example the + next to 02-01 was clicked.



In order to retrieve a walking list for a specific street one must click on the street name, not on the + that appears by the street name.

In the example below, Arista Manor Way in Germantown was selected. The street name, city and district precinct appear at the top of each page. Each street is sorted by even house numbers, meaning that all even house numbers are grouped, and then all odd house numbers are grouped. Even and odd house number groupings are divided by a red, white and blue line.



Each row contains the registered voters name, house number, gender, current age, party, and voting history.

The voters name appears in black if they are unaffiliated, blue if they are a registered Democrat, red if they are a registered Republican, green if they are a member of the Green party and purple if they are affiliated with another party. The party affiliation also appears in the Party column.

Voting history appears on the right, in columns. Below the year are abbreviations for presidential general election (PG), presidential primary (PP), gubernatorial primary (GP) and gubernatorial general (GG). A Y appears in the column if the voter cast a vote in the election and an N appears if the voter did not cast a vote.

5 Voter Street Level Analysis

A district precinct and street level demographic analysis is provided on the CD or USB Flash Drive as “StreetAnalysis.pdf” in Adobe Acrobat format (PDF). Due to the size of the file and for performance reasons, it is strongly recommended that the file be copied to a local drive and not accessed directly from the CD.

The bookmarks on the left side of the screen allow you to navigate by district precinct and by street name. District precincts are listed in order as illustrated in the example below. The bookmark 02-01 contains all of the streets with active voters in that district precinct. By clicking on the + next to a specific district precinct the streets in that district precinct are listed. By clicking on the district precinct the demographic information for that district precinct is displayed. In the example below the + next to 02-01 was clicked to display the streets in the district precinct. District precinct 01-02 was clicked to display demographic information for that district precinct.

Demographic information for a street can be displayed by clicking on the street name.

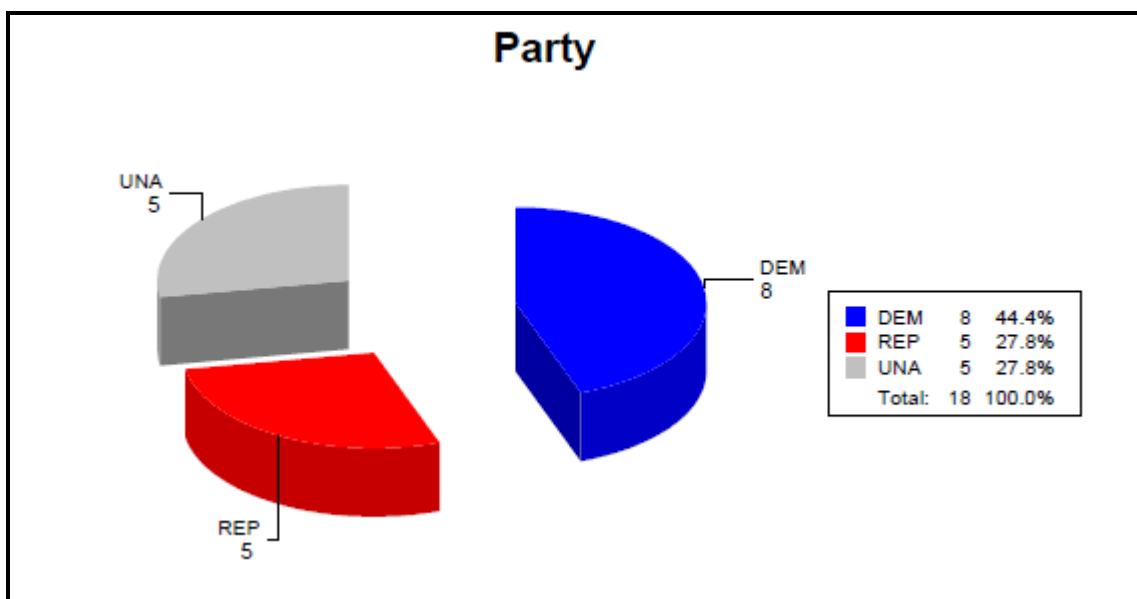
Based on voter registration data, three demographics are presented graphically on the page: party, gender and age.



A pie chart is presented that displays the street population by party. Each slice of the pie is labeled with the number of active voters and their party.

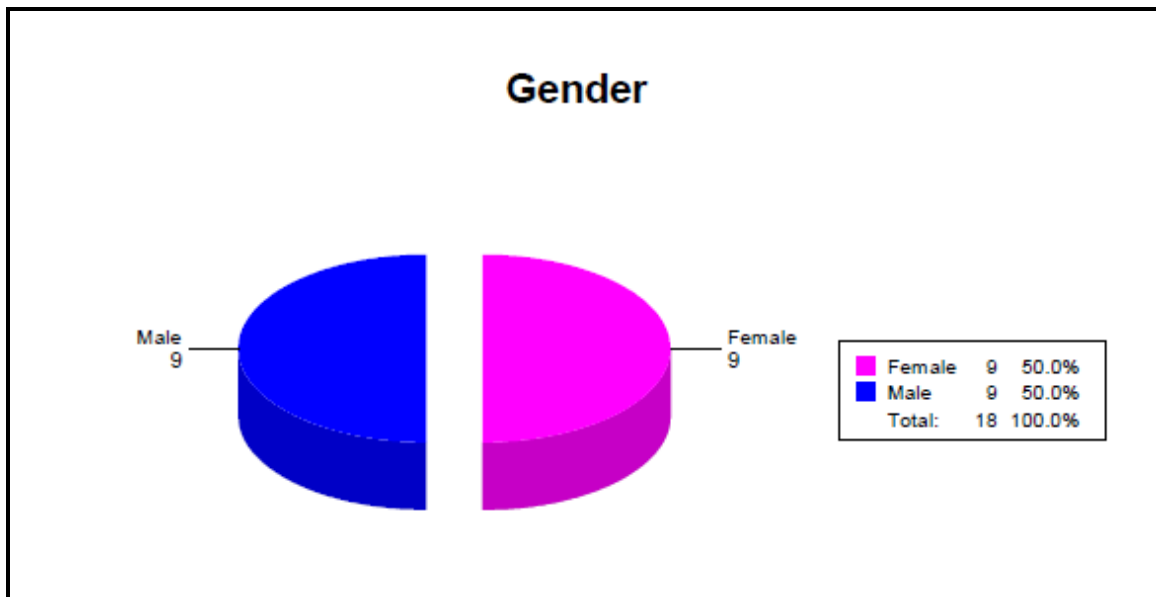
The legend to the right of the pie chart provides the number of voters affiliated with a party, the percentage of voters on the street or in the district precinct who are affiliated with a party and the total number of active voters.

In our example below we can see that on the selected street there are 5 unaffiliated voters who are 27.8% of the voting population on the street.





The second demographic on the report is gender. Each pie slice is labeled with number of voters by gender. In the example below, there are an equal number of males and females on the street. You will also notice that the total population by gender will, of course, match the total population by party.



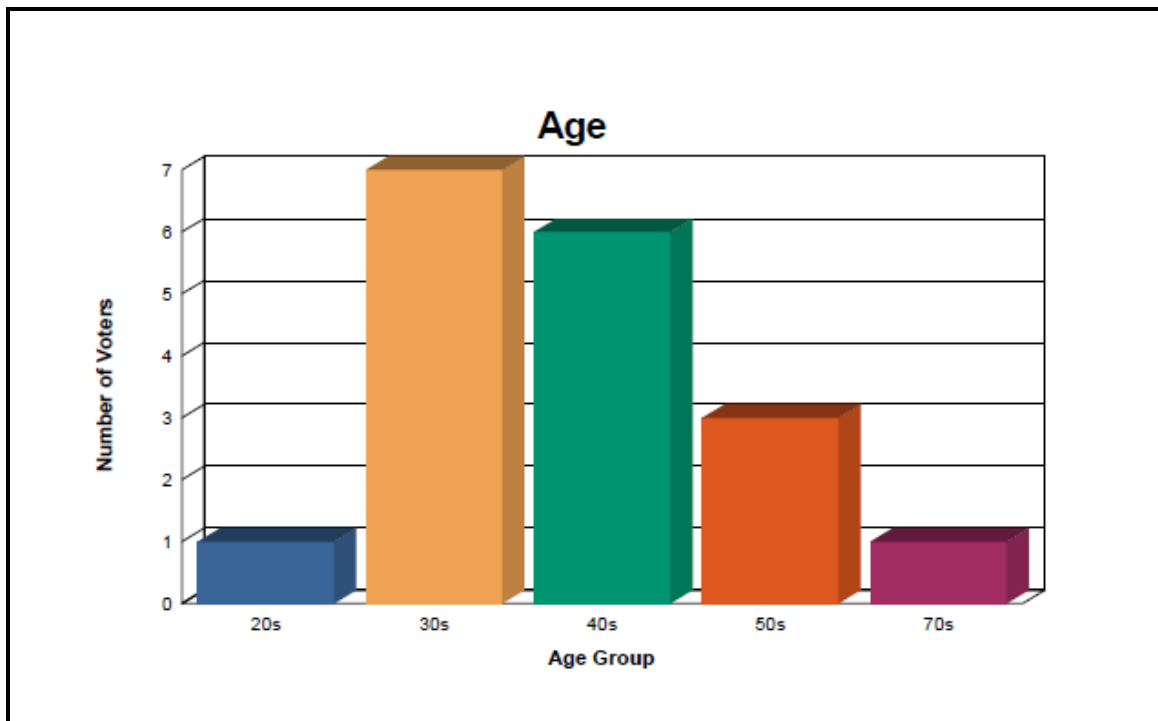


The final demographic presented in the report is age by decade. A bar chart (see below) indicates how many registered voters fall into each age group. There are two special age groups not shown in the example below:

- 18 – 19 groups of active voters under the age of twenty years old.
- Over 99 groups of any active registered voters who are 100 years old or older.

Bars are only generated for age groups where a member of the population fits into that age group. In the example below, no active voters are:

- Under twenty years old
- Are between the ages of sixty and sixty nine
- Are over seventy nine years old

6 Mailing Labels

A complete set of mailing labels for all active voters in Montgomery County is provided on the CD or USB Flash Drive as “Labels.pdf” in Adobe Acrobat format (PDF). This file works with mailing labels that are compatible with the Avery 5962 and Avery 5162 formats. Labels from providers other than Avery can be successfully used if they are formatted the same way as the Avery labels. The BOE does not endorse Avery or any label provider.

Labels are ordered by:

1. district precinct
2. party
3. ZIP code
4. street name

On the first line of each label is a code that indicates the district precinct and party.

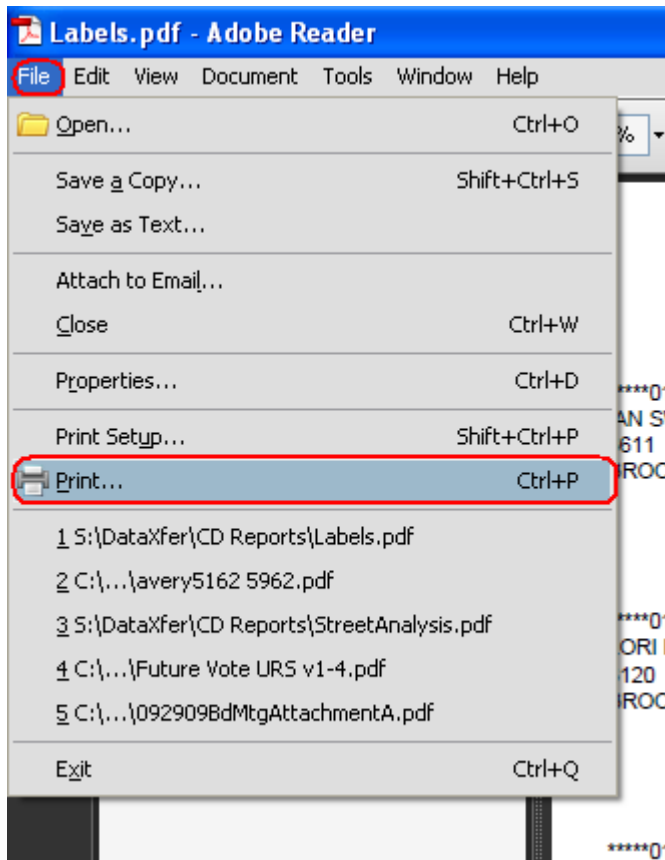

The first five characters of the code are asterisks. The next two digits indicate the election district. The election district is always followed by a zero. The ninth and tenth characters, following the zero, indicate the precinct. The last character represents the party.

Mailing labels are provided in page format and as such individual labels can not be selected and printed. Additionally the order of the labels can not be changed.



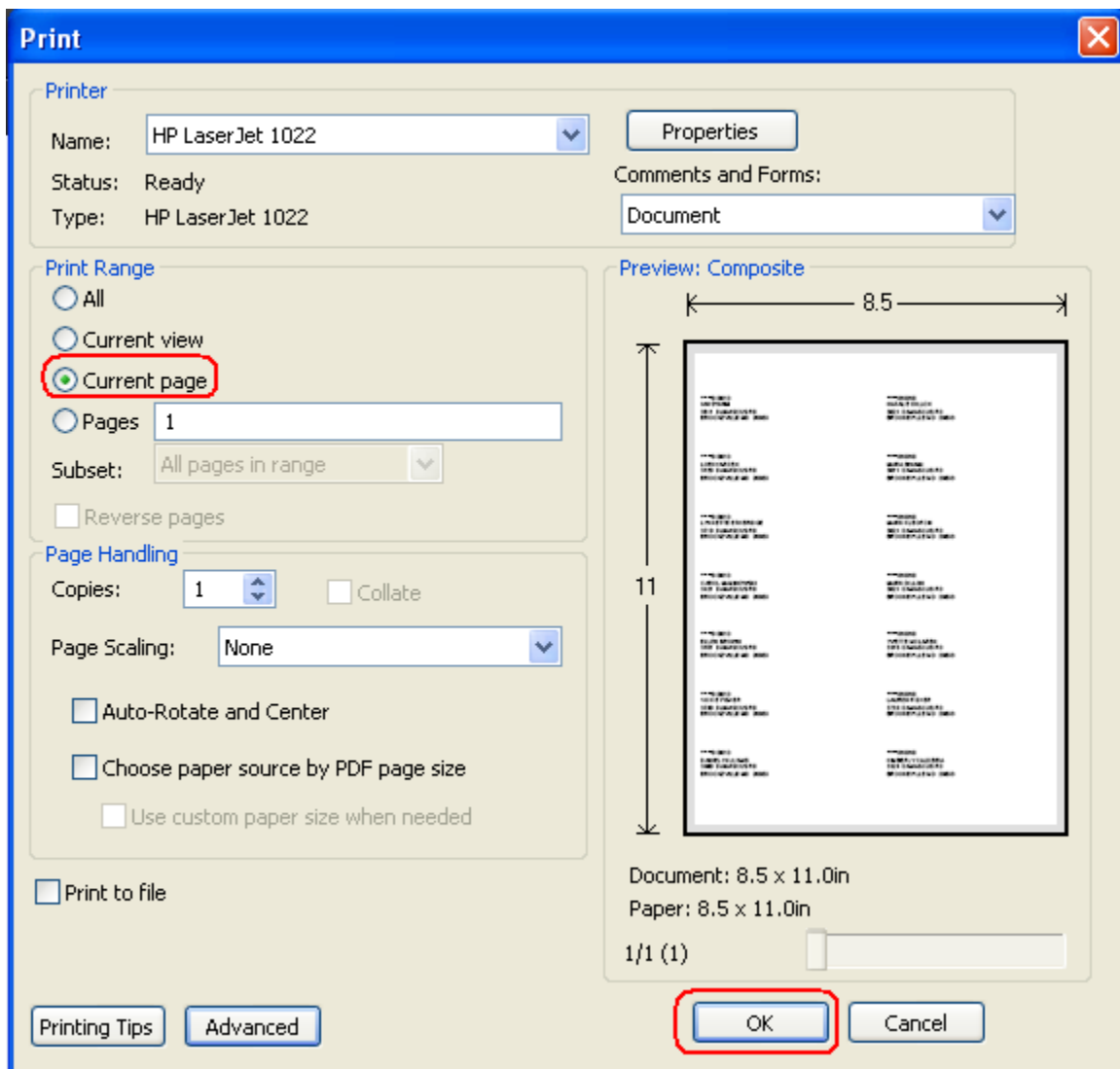
In order to print labels one should select the page that one wishes to print and select *File* from the menu bar and then select *Print*.





Follow the instructions provided with your printer and labels to correctly load the labels. Select current page and then click the *OK* button. Do NOT select *Current view*. Use care not to select *All* as this would produce over 40,000 pages of labels.

One may also wish to print a range of pages and that can be accomplished by selecting *Pages* and entering a range such as 2345 – 2367.

A listing of all residential streets in Montgomery County is provided on the on the CD or USB Flash Drive as “StreetDir.pdf” in Adobe Acrobat format (PDF). This file provides a listing of the Legislative, Congressional, County Council, School Board and Municipal Districts for each street. The report is sorted in alphabetical order by street name. In addition to the above information, the report also includes ZIP code, City, House Number Range, and Street Name.

8 Frequently Asked Questions

8.1 Data File

8.1.1 Can the Montgomery County Board of Elections help me develop reports or manipulate the registered voter information?

The Montgomery County Board of Elections will provide you information about the data provided and has provided some key reports for analysis such as the demographics reports. 8.1.2 What tools can be used to manipulate the voter data file?

There are many commercial software packages that can be successfully used to manipulate the voter registration information. The Montgomery County Board of Elections does not endorse or support any particular software, and provides data in a format that is compatible with many database products. Common tools one may select to manipulate the voter data include Microsoft Access, Open Office Base (a free product) and Filmmaker Pro. Additional information can be obtained on these products at www.microsoft.com, www.openoffice.org and www.filemaker.com respectively. See questions 4.11 and 4.12 for specifics on how to import data into Microsoft Access and Open Office Base.

8.1.3 Where can I receive training on tools to manipulate data?



There are many sources for training including commercial training providers, local colleges as well as online courses offered by a variety of providers.

8.1.4 Can the Board of Elections respond to special data requests?

The Board of Elections provides data that is available in a standard format. By providing standardized complete data, the Board of Elections reduces the cost of providing data, provides periodic current data, simplifies the data request process and reduces the time required to provide data. 8.1.5 In what format is the data provided?

All data is provided in quote and comma delimited format with the first row of data listing the field names. This generic format works with a wide variety of software.

8.1.6 Does the Board of Elections provide municipal elections history?

No. However, the Board of Elections does provide a list of registered voters identified by municipal ward. For municipal elections history please contact the municipality directly.

8.1.7 How much voter history is provided?

Voter history is generally provided for the last ten presidential and gubernatorial elections, this includes primary and general elections.

Microsoft Excel has a limit of 1,048,576 records. In most cases, this limit prohibits use of Excel to manipulate the data provided it exceeds this limit.

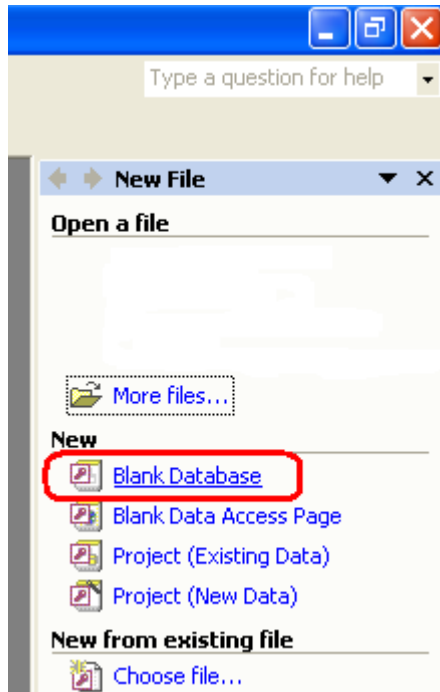
8.1.10 How can I import the data provided into Microsoft Access?

The following procedure was developed using Microsoft Access 365:

1. Place the CD or USB Flash Drive in the CD Drive or USB Drive

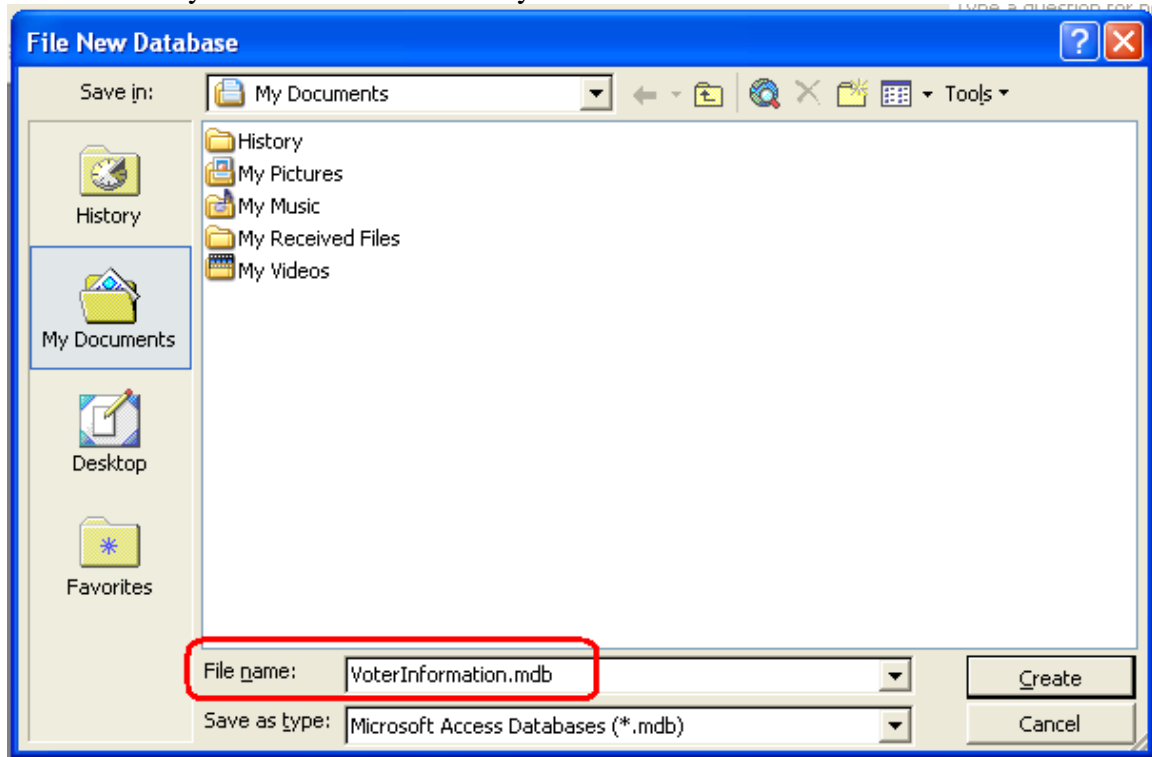


2. Open Microsoft Access and click on *Blank Database* on the right side of the screen.

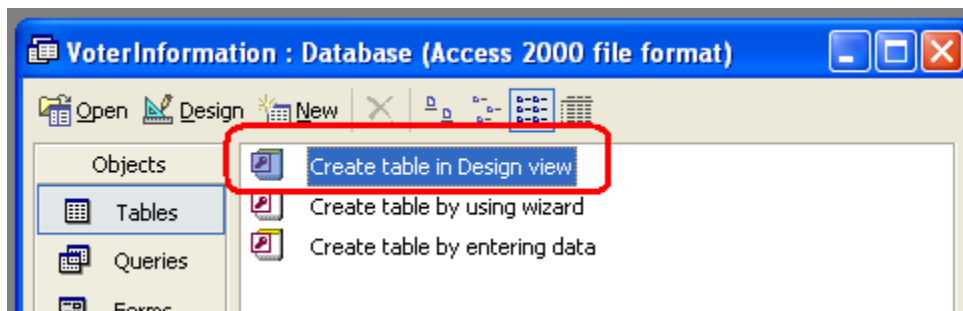




3. The *File New Database* window is displayed. In the *File Name* box type a file name that you would like to use for your database.

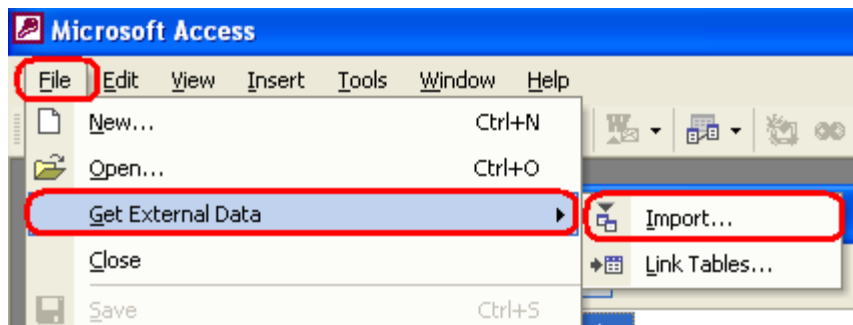


4. Click once on *Create table in Design view*



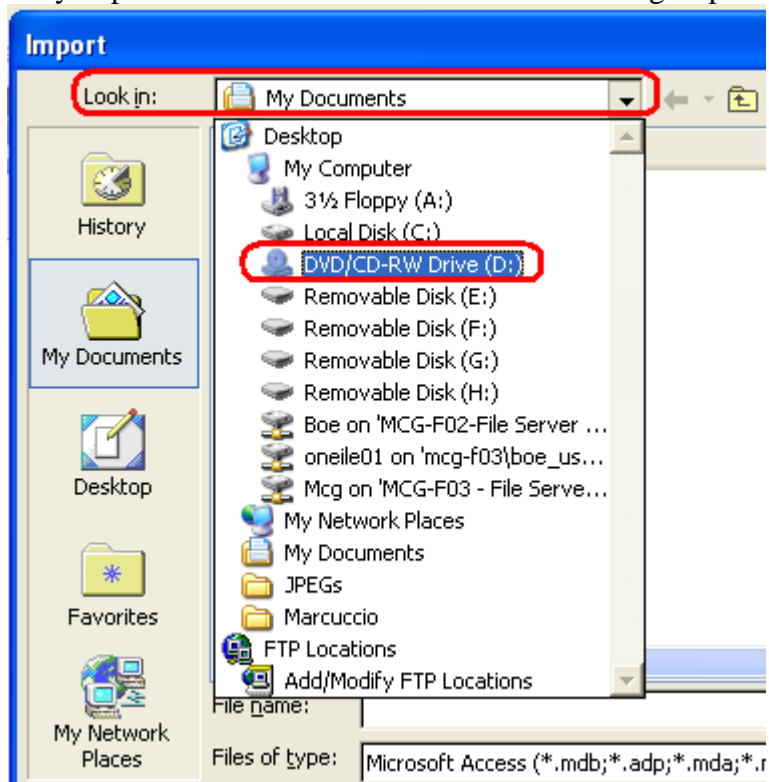


5. Click on the *File* menu option from the pull down menu bar at the top of the screen, select *Get External Data* and select *Import*.



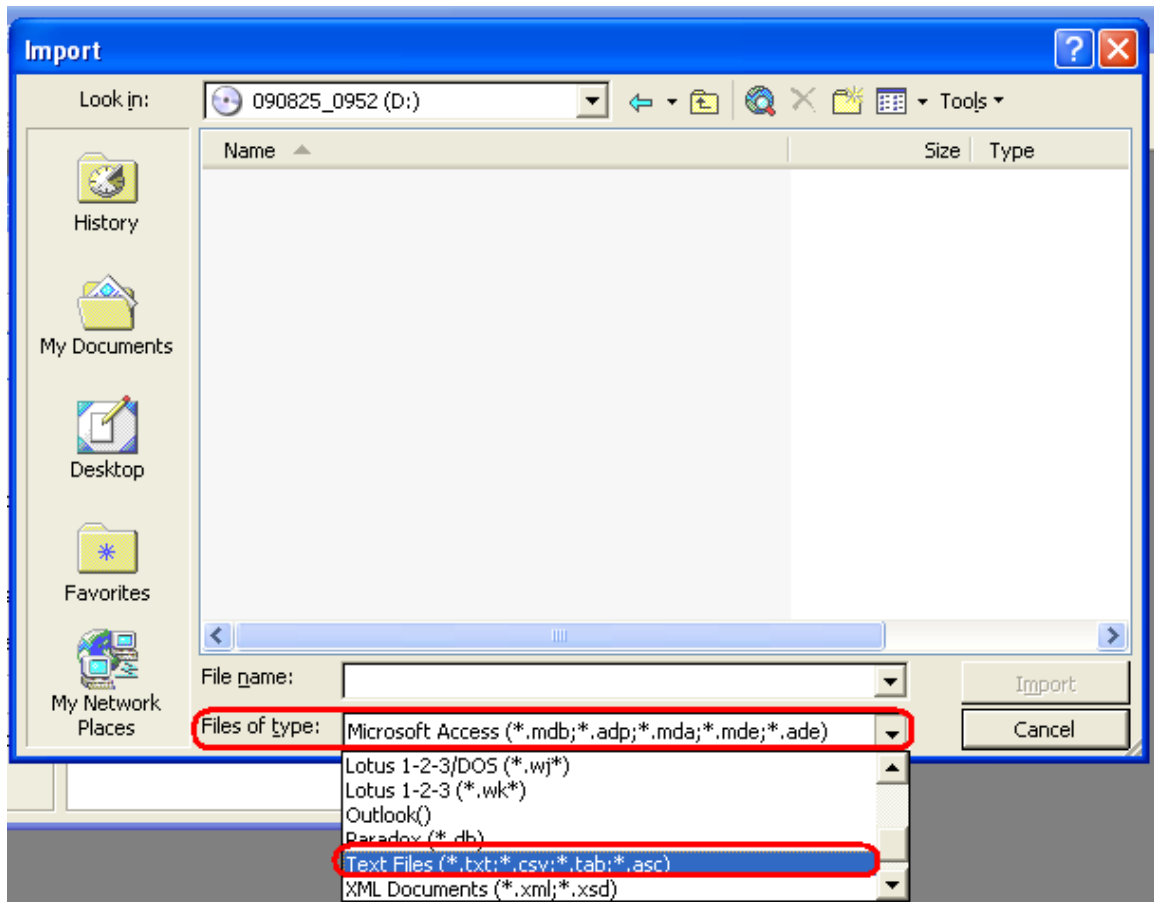


6. In the *Import* Window click on the *Look In* pull down and select the CD drive that you placed the Voter Information File in during step 1.

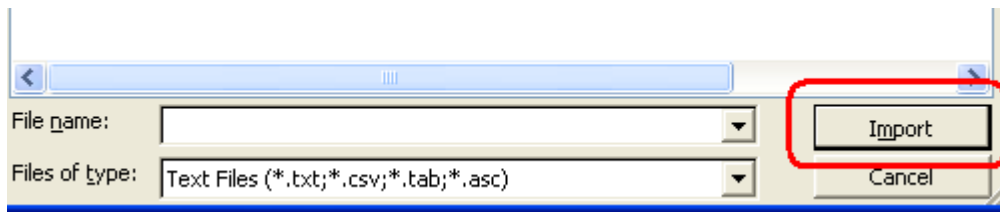




7. In the *Import* Window click on the *Files of Type* pull down and select *Text Files*

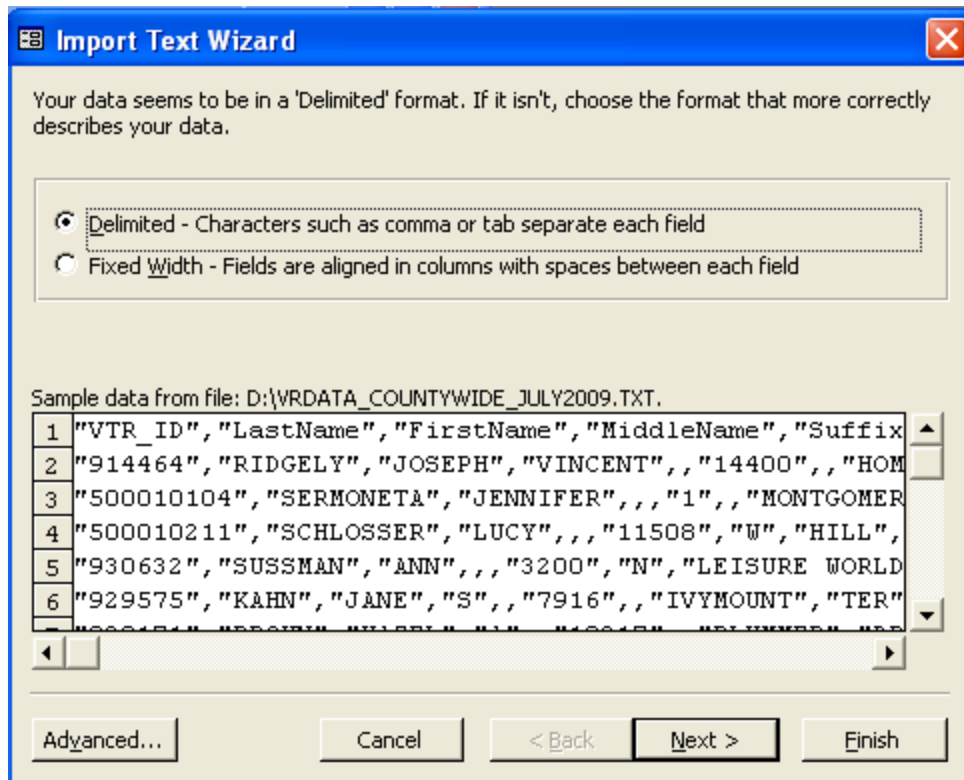


8. Select the file you wish to import and click the *Import* button.

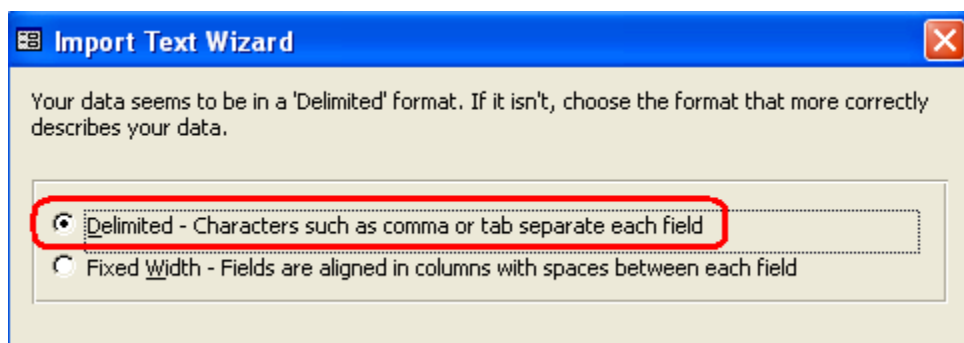




9. The *Import Text Wizard* window appears.



10. Ensure that the *delimited* radio button is selected.



11. Click the *Next* button.



12. Ensure delimiter is set to *Comma* (default value), check the *First Row Contains Field Names* check box and ensure that *Text Qualifier* is double quotes (default value).

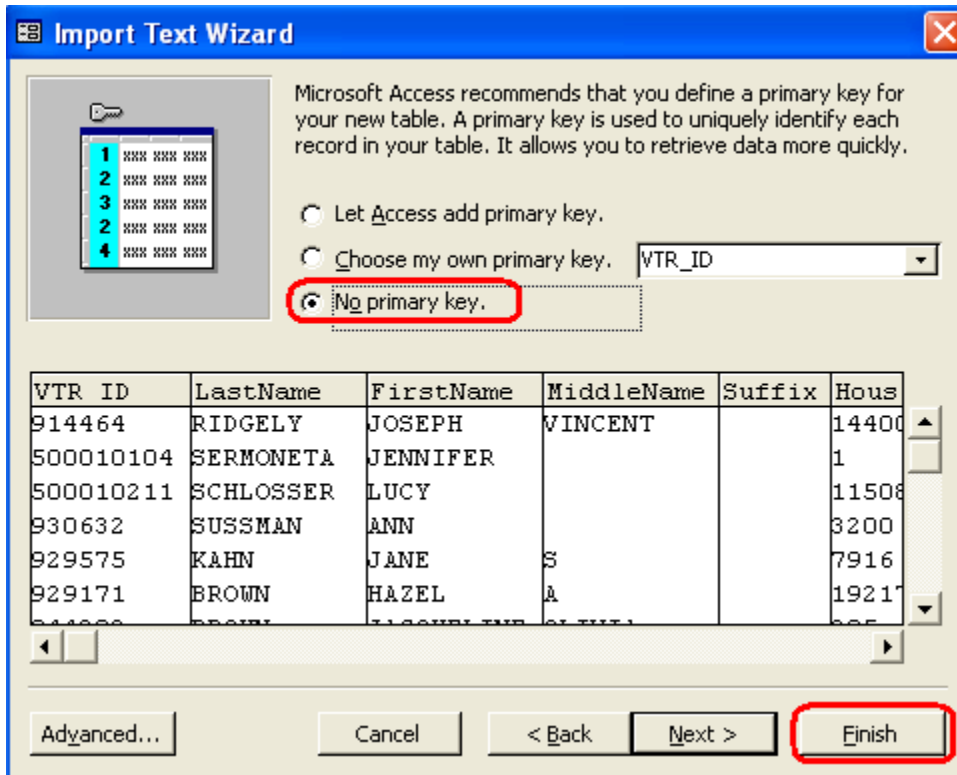

15. Click the *Next* button two times.

16. Select the *No Primary Key* radio button and click the *Finish* button to import the data.

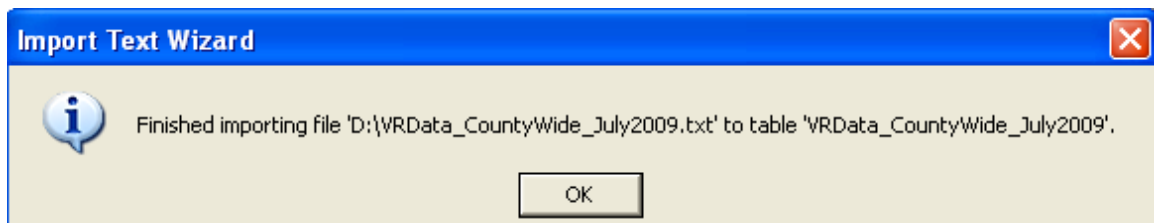


17. The import may take up to several minutes depending on the configuration of your computer. You can monitor the progress of the import by watching the bar in the lower left corner of the screen.

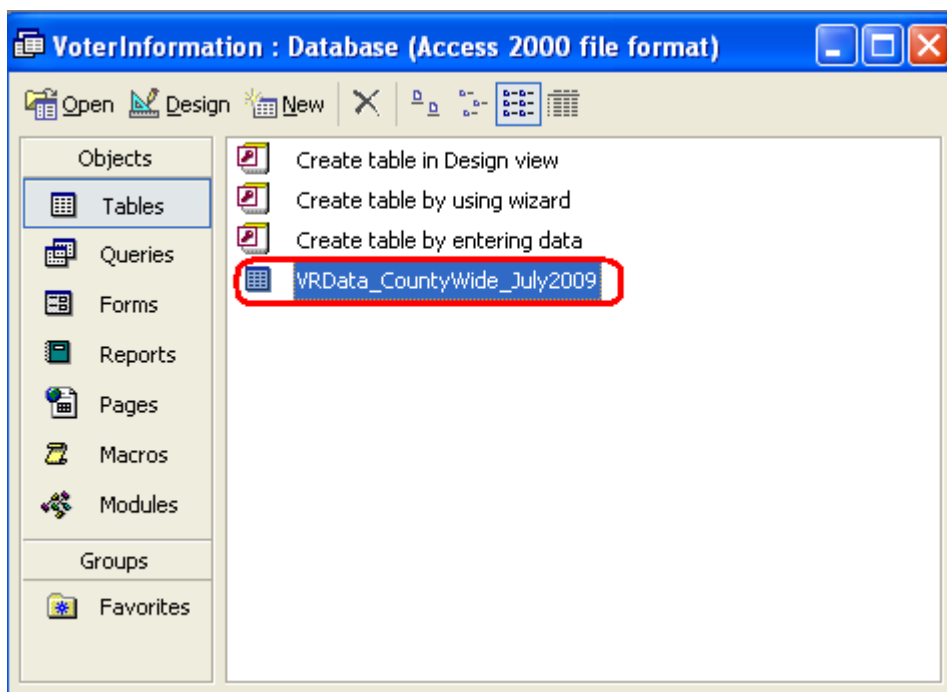




18. After the import is complete an *Import Text Wizard* information window will appear indicating that Access is finished importing the file.



19. Click the *OK* button and a new table object will appear.

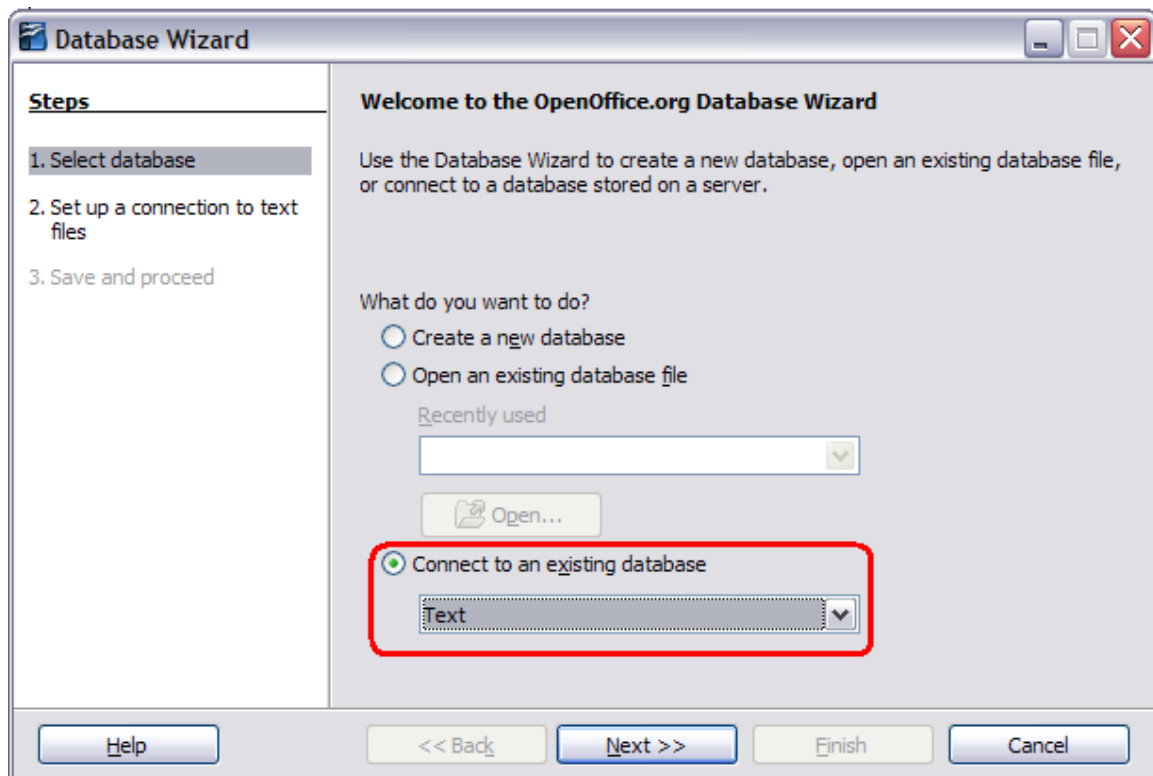




8.1.11 How can I import the data provided into Open Office Base?

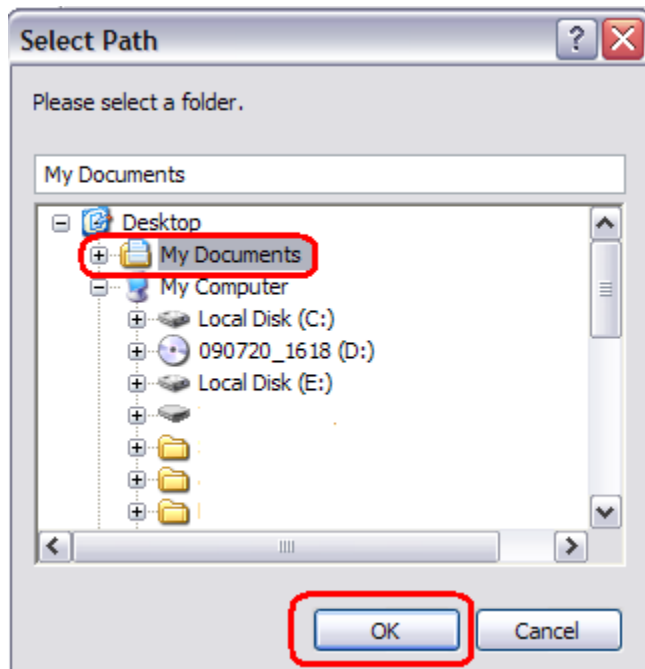
The following procedure was developed using Open Office Base version 3.1:

1. Place the CD in the CD Drive.
2. Copy the data file to a local drive, for example, My Documents.
3. Open *Open Office Base*, select *Connect to an existing database* and click the “Next >>” button.



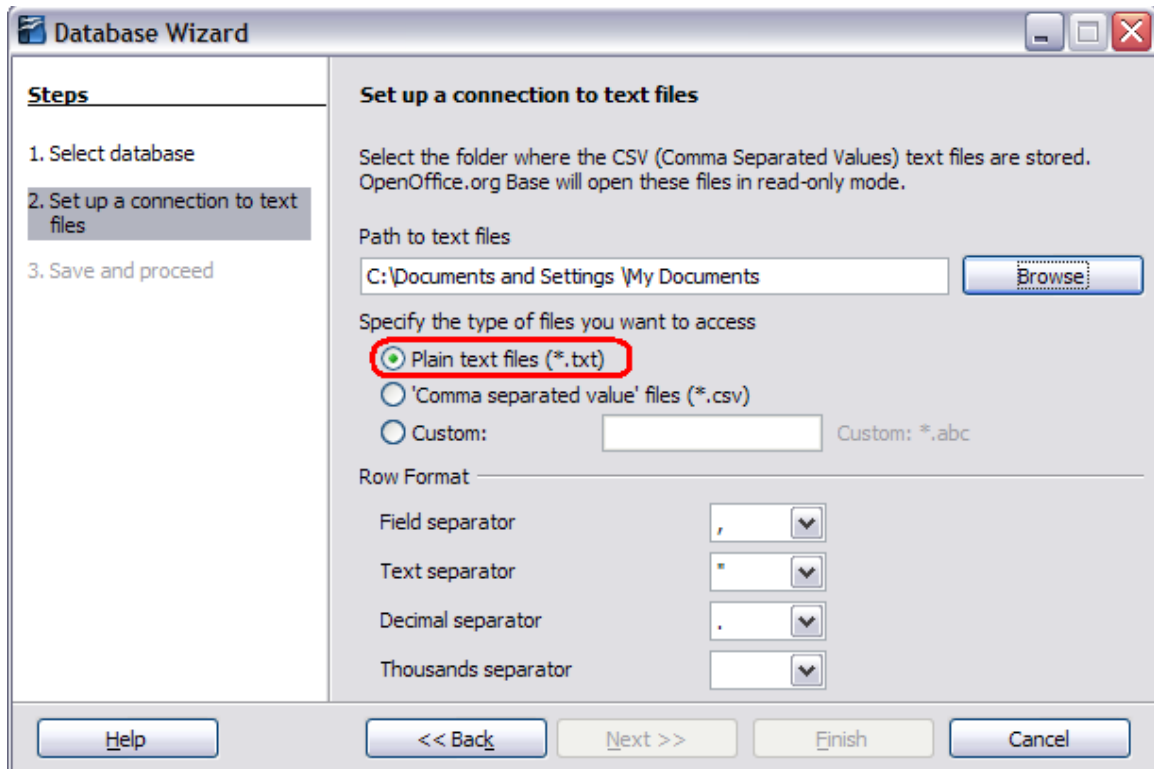


4. Click the browse button and in the *Select Path* window select the folder where you placed the data file from the CD and click the *OK* button.



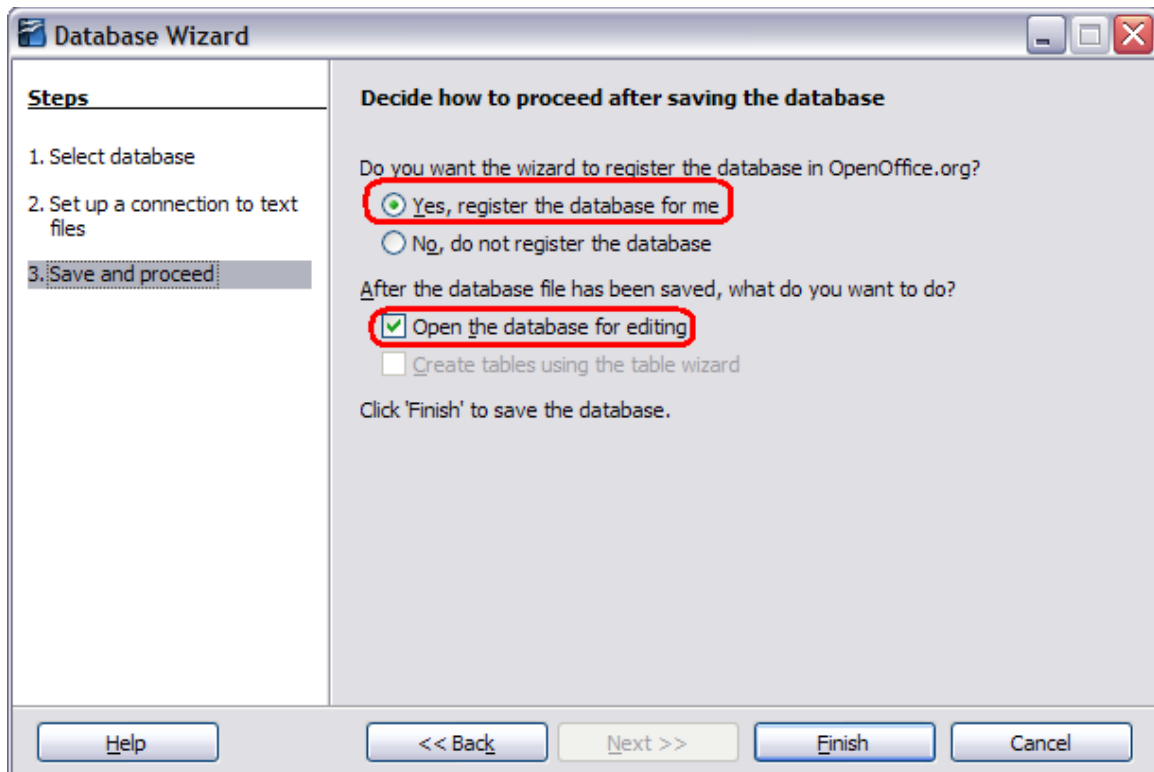


5. Select the *Plain text files (*.txt)* radio button.

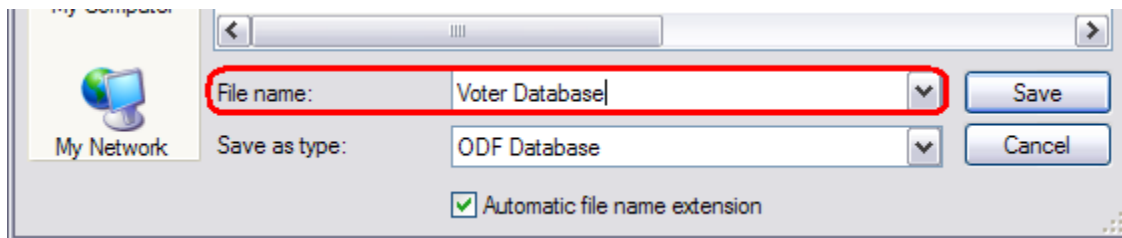




6. Ensure the *Yes, register the database for me* radio button is selected and the *Open the database for editing* checkbox is checked. Click the *Finish* button.



7. In the *Save As* window enter a file name for the database and click the *Save* button (see partial screen below).





8.2 Walking List & Voter Street Level Analysis

8.2.1 The Walking List & Voter Street Level Analysis reports will not open.

These reports require a free program called Adobe Acrobat Reader. You can obtain a copy of this software on the internet at: <http://get.adobe.com/reader/>

8.2.2 The walking list & Voter Street Level Analysis reports take a long time to open.

Both of these files are relatively large, the Voter Street Level Analysis is especially large. In order to improve performance and make the files open more quickly it is highly suggested that you copy the files to your computer and not access the files directly from the CD.

8.3 Mailing Labels

8.3.1 The Mailing Label report will not open.

This report requires a free program called Adobe Acrobat Reader. You can obtain a copy of this software on the internet at: <http://get.adobe.com/reader/>



8.3.2 The names and addresses are not printing correctly on the labels.

Ensure that the labels being used are compatible with the Avery 5962 or 5162 formats. When printing a single page ensure the *Current Page* option is selected and NOT the *Current View* option.

8.3.3 Can only selected labels be printed?

Labels can only be printed by page. Use of the provided data file will allow specific generation of labels in any format designed using the selected tool, such as Microsoft Access or Open Office Base.

8.3.4 Why are the labels in all capital letters and commas missing?

The U.S. Postal Service issues guidelines to help ensure that mail is readable by optical scan technology. The U.S. Postal Service recommends that all characters be in upper case and provides specific guidance of the use of punctuation. This is detailed in “Quick Service Guide – 602” and is available on the USPS website at www.usps.com.

8.3.5 I have recommendations for improvement in the information provided by the Board of Elections, how do I share my suggestions?
