

EV PURCHASING CO-OP DEALERSHIP INCENTIVE

Sport Chevrolet

Chevrolet is offering home charging installation to new Chevy Bolt or Bolt EUV customers. It's installation made easy! Chevrolet has appointed Qmerit to pair you with an expert electrician to install a 240-volt (NEMA 14-50) outlet & 40-amp dedicated breaker at your home. Home installations will either be 'standard' or 'non-standard,' depending on your home setup.

Standard installation is paid for in full (including permit fee) by Chevrolet when your home meets the standard requirements. In most cases, this means you live in a singlefamily home, have a dedicated meter, an attached garage, and available ampacity. Nonstandard installation is still managed through Qmerit, but your home setup is out-ofscope for the standard installation. Chevrolet will pay up to \$1,000 towards your installation and up to \$250 towards your permit. Your Qmerit electrician will provide you a quote. Once your approval is confirmed, the electrician will schedule your install. Payment for the remaining balance is required upon completion of the installation.

If a home installation is not possible or not desired, Chevrolet is offering a \$500 EVGo public charging credit so you can charge on the go. This is great for customers who may live in an apartment building or rental and aren't able to install a new outlet, or for customers who already have home charging installed. Note: EVgo public charging credits can be used at several other public charging stations (e.g. ChargePoint) through interoperability ("roaming") agreements.

Sport Cadillac

Cadillac is providing up to \$1500 towards the cost of installation (labor, permit, materials) through Qmerit, which will be paid directly to the Qmerit electrician. Any additional costs are the customer's responsibility. Cadillac has appointed a dedicated LYRIQ Qmerit Concierge to be the single point-of-contact to provide guidance and transparency to customers throughout the home installation process.

The customer's Qmerit electrician will provide them with a quote. Once approved, the Qmerit electrician will pull all required permits, schedule the installation and customers will pay them the remaining balance (if any) at the time installation is complete. NOTE: Customers who receive installation prior to delivery and then cancel their order will be responsible for reimbursing GM the total amount of credit paid on the Customer's behalf, up to \$1,500.00, direct to GM, upon GM's request.

If home installation is not possible or desired the alternative is the 2-year unlimited charging plan through EVgo. The time period shall begin once Customer redeems the EVgo activation code, which gets sent by GM upon vehicle delivery. This is great for Customers who may live in an apartment building or rental and aren't able to install a level 2 home charging system or for customers who already have home charging installed. Customers must accept offer terms and conditions in order to take advantage of either offer.
