## FOURTH AMENDMENT TO LEASE AGREEMENT

THIS FOURTH AMENDMENT TO LEASE AGREEMENT (this "Fourth Amendment") is made this <u>(T</u> day of December, 2015 by and between (i) UNITED THERAPEUTICS CORPORATION, a Delaware corporation (the "Lessor"); and (ii) MONTGOMERY COUNTY, MARYLAND, a body corporate and politic and political subdivision of the State of Maryland (the "Lessee").

## **RECITALS**:

- R-1. The Lessor (as successor to Spring Street Associates Limited Partnership) and the Lessee are parties to a Lease Agreement dated December 3, 1999, as amended by First Amendment to Lease Agreement dated August 4, 2004, Second Amendment to Lease Agreement dated August 26, 2009 and Third Amendment to Lease Agreement dated November 10, 2014 (collectively, the "Lease") pursuant to which the Lessee leases from the Lessor the premises described as Suite 407 in the building located at 1109 Spring Street, Silver Spring, Maryland.

  - 2. Section 2 of the Lease is hereby amended by adding the following:

"The Lease Term is hereby extended and shall expire on October 31, 2016 (the 'Fourth Extended Term') upon the same terms and conditions as currently set forth in the Lease. There are no further options to extend the Lease Term beyond the Fourth Extended Term."

3. Except as amended hereby, the terms and provisions of the Lease shall remain in full force and effect and are hereby ratified, confirmed and reaffirmed by the parties in all respects. Any capitalized terms not defined herein shall have the same meanings ascribed to them in the Lease. This Fourth Amendment may be executed in counterpart signature pages.
