The monthly meeting of the Commission on Common Ownership Communities was called to order at 7:06 pm by Chairman Mark Fine

- Minutes approved: Commissioner Burrows moved to approve the minutes of the May 1, 2019 monthly meeting as presented. The motion was adopted; Commissioner Fishbein abstained. Commissioner Burrows moved to amend the agenda, moving the DHCA Staff report to follow Community Forum. Motion passed by unanimous consent.
- 2. **Community Forum:** Ginger Naglee asked where written rules concerning committee meeting minutes could be found. JoEllen Bilanin asked where to find issues of the CCOC Newsletter.
- 3. **DHCA Staff report:** Monthly data report for May 2019 was discussed. The Office of Common Ownership Communities is taking responsibility for registration and updating association leadership and rental information. Effort to contact associations has increased number of associations registered, which should increase fees collected by County.
- Jurisdiction Default cases: Commissioner Burrows moved to accept jurisdiction on all cases, seconded by Commissioner Fishbein; motion passed, Commissioner Gardner abstained.

5. Jurisdiction - Contested cases:

The Americana Centre Condominium – Commissioners Gelfound and Perper disclosed possible conflict of interest as they work for same management company, and did not take part in discussion or vote. Commissioner Burrows moved to accept jurisdiction and refer the case to a hearing panel. After discussion by the balance of commissioners, the motion was passed by unanimous consent.

#2019-044 North Creek Villas Condominium Assoc. v. Edward Feinstein – Commissioner Gardner moved to accept jurisdiction and refer case to a hearing panel. After discussion, the motion passed by unanimous consent.

#2019-046 Altayework Berhaneselassi & Bililingne Senbet v. Hill Top Condominium – Commissioner Gelfound moved to reject case as Md. Law trumps covenants on responsibility for damages from

falling tree. After discussion, motion was withdrawn. It was noted that Complainant did not give sufficient explanation of association's alleged negligence and Commissioner Gardner moved that a decision on jurisdiction be deferred until next month [July] to allow Complainant to supplement his complaint. The motion passed by unanimous consent.

#2019-057 <u>Luz Cruz v. Top of the Park Condominium Assoc</u>. - Commissioner Gelfound moved to accept jurisdiction only on soil erosion segment of complaint, but the motion failed, Commissioner Gelfound the only vote in favor. After further discussion Commissioner Gardner moved to accept jurisdiction and refer the case to a hearing panel. The motion passed, with Commissioner Gelfound the only vote against.
