- 1. **Proof of Quorum:** There being 11 Commissioners Present the meeting was called to order.
- 2. **Welcome and Introductions**: The Chair welcomed all in attendance.
- 3. **Approval of Agenda**: Commissioner Holmes moved to approve the April Agenda. Commissioner Heron seconding. Commissioner Heron called for an amendment to remove case 2022-071 from the agenda. All voted in favor and the motion carried.
- 4. **Approval of Minutes**: Commissioner Anderson moved to approve the minutes of March 2022 monthly meeting. Commissioner Herron seconded. All voted in favor and the motion carried.
- 5. Community Forum: There were no questions from the audience during the open forum.
- 6. Submission of disputes for Commission consideration: Jurisdiction –

#2022-060, Turtle Rock Condominium v. Zahedinia, et al. – Commissioner Anderson moved Accept Jurisdiction of the case and Commissioner Moore seconded the motion. The motion was carried by the Commission, by unanimous consent.

#2022-062, Longmead Crossing CSA v. Gonzales – Commissioner Anderson moved Accept Jurisdiction of the case and Commissioner Holmes seconded the motion. The motion was carried by the Commission, by unanimous consent.

#2022-069, Longmead Crossing CSA v. Siriboe, et al. — Commissioner Anderson moved Accept Jurisdiction of the case and Commissioner Murthy seconded the motion. There was a discussion between the OCA, Chair and Commissioner Seebold regarding "acceptance of jurisdiction" as opposed to using the terms "default" or "contested". Mr. Wilson (OSA) stated that it did not matter if we used the terms "default" or "contested". The point that matters is that the complainant, either homeowner or Association files a case and no response is filed, it is a default case (uncontested) The complainant still must prove that they are entitled to prevail. Commissioner Herron also had his hand raised, mentioning that he was also going to reiterate what Mr. Wilson stated. The motion to accept the case was carried by the Commission, by unanimous consent.

#2022-035, Walston, et ux. v. Fox Chapel North Homes Association - Commissioner Holmes moved to Accept Jurisdiction of the case and Commissioner Anderson seconded the motion. Being no Discussion, the motion was carried by the Commission, with Commissioner Herron Recusing.

#2022-054, Candace Otto v. Kenwood Place Condominium -Commissioner Holmes moved to Accept Jurisdiction of the case and Commissioner Anderson seconded the motion. After a brief discussion, the motion was carried by the Commission, with Commissioner Smith Recusing. There was a brief discussion regarding Ms. Steinbach recusal, Mr. Wilson stated Ms. Steinbach need not recuse at this time.
