#2022-094, Longmead Crossing CSA v. Ondiek, Et. Al. – Commissioner Murthy moved Accept Jurisdiction of the case and Commissioner Holmes seconded the motion. The Vice Chair called for discussion, hearing none, a roll call vote was called. The motion was carried by the Commission, by unanimous consent.

Commissioner Herron also commented in support of the staff. A roll call vote was called. The motion was carried by the Commission, by unanimous consent.
