- 1. **Proof of Quorum:** All Fourteen (14) Commissioners Present, Ten (10) current and Four (4) new Commissioners.
- 2. **Welcome and Introductions**: The Chairwoman welcomed all in attendance and had all current and new Commissioners and staff introduce themselves.
- 3. **APPROVAL OF THE AGENDA**: V. Chair motioned to amend the agenda switching items 5 and 6; Commissioner Nerlinger 2nd the notion; the motion carried unanimously
- 4. **Approval of Minutes:** Commissioner Anderson moved to approve the November 2022

Minutes; Commissioner Holmes' 2nd the motion; the motion passed unanimously

- 5. Election- Both Chairwoman and Vice Chair were reelected by acclimation.

 Commissioner Moore moved; Commissioner Holmes 2nd the motion; the approval by acclimation carried unanimously** New Commissioners were advised by Attorney Wilson in accordance with 10-B they would not be allowed to assist with taking actions until they completed all necessary requirements. ***
- **6.** Community Forum: No questions were submitted by constituency.
- 7. Report of the Chair: Chairwoman provided an overview of the 2022 Commission success and thanked all the Commissioners for their contributions
- **8. OFFICE REPORT**: Ms. Katrivanos, COC Interim Manager would like to adopt a new procedure that would involve: 1) requiring investigators to present each case; 2) the investigators would then propose a date for the hearing; and 3) they would like the Commissioners to volunteer to serve on that hearing panel as each case is accepted. This is an effort to speed up the process of Panel selection. This is the process COLTA uses successfully (The Commission on Landlord Tenant Affairs). New Commissioners are being requested to observe upcoming hearings to get acclimated with the procedure, and protocols for participation the future hearings and other cases coming before the Commission.
 - After discussion on start times for hearings, The Chair suggested an ad-hoc committee to further explore this process. She asked that the committee conclude the discussions by January 25th. The special Ad Hoc committee will only look at the process, and hours for hearings. The OCA advised we could not set a max. time for hearings but could set time limits on the particular date and then if not concluded, an additional date could be added if the hearing was not concluded in one day. The Chair asked Commissioner Seebold to chair the special Ad Hoc committee which has a specific duty to make improvement recommendations to the Commission.
