Minutes of the Monthly Meeting

Wednesday, December 6, 2023

The monthly meeting of the Commission on Common Ownership Communities was called to order at 7:24 p.m. by Commission Chair Cheryl Walker.

- 1. **Proof of Quorum and Welcome:** There being 10 Commissioners present, the meeting was called to order. The Chair welcomed all in attendance.
- 2. Approval of Agenda: Commissioner Anderson moved to approve the Dec. 6, 2023, agenda and Commissioner Steinbach seconded. With no objections, the Dec. 6, 2023, agenda was approved by general consent.
- **3. Approval of Minutes:** Commissioner Anderson moved to approve the Nov. 1, 2023, minutes, and Commissioner Holmes seconded. With no objections, the Nov.1, 2023, minutes were approved by general consent.
- **4. Chairwoman's Report:** Commissioner Walker introduced committee chairs (Nerlinger, Eucation; Steinbach, Communications; Holmes, Legislative), who summarized accomplishments in 2023. [Commissioner Hall joined the meeting at 7:48 p.m.]
- **5. Keynote Speaker, John Tsitos:** Mr. Tsitos gave an overview of common ownership communities, their advantages, and misconceptions about them.
- **6. Presentation by the Department of Environmental Protection:** Ms. Ariaza and Ms. Oliver gave information about their department's programs and grants.
- 7. Presentation by the Office of Licensing and Registration: Ms. Price discussed details about the licensing and registration of common ownership communities in Montgomery County.
- **8.** Community Forum: There was a question from the audience during the open forum regarding the role of the CCOC and advocating to the Montgomery County Council.
- **9. Submission of disputes for Commission consideration:** Jurisdiction and reconsideration Ms. Fabayo presented the following cases to the Commission:

2024-004 Clarksburg Village Community Association, Inc. v. Hampton, et al. – Commissioner Mezey moved to accept jurisdiction of the case and Commissioner Anderson seconded the motion. The motion was carried by the Commission, by unanimous consent.

2023-064, **Blumenstock**, **et al. v. Americana Finnmark Condominium**, **Inc.** – Mr. Wilson corrected a misquoted citation in the case report and Commissioner Seebold requested staff review office documents. Commissioner Anderson moved to **accept jurisdiction of the case** and Commissioner Mezey seconded the motion. The **motion was carried by the Commission**, by general consent, with Commissioner Steinbach recusing.

2024-017, Freeberg v. Fallsreach HOA – Commissioner Holmes moved to accept jurisdiction of the case and Commissioner Hall seconded the motion. The motion was carried by the Commission, by general consent, with Commissioner Steinbach recusing.

2023-015, Gallagher, et ux. v. Hampshire Greens HOA – Commissioner Anderson moved to **deny reconsideration of the case** and Commissioner Mezey seconded the motion. The **motion was carried by the Commission**, with Anderson, Freeman, Hall, Holmes, Mezey, Seebold, Walker and Zmuda in favor, Nerlinger opposed, and Steinbach and Moore recusing.

10. New Business – Mr. Espin said he will send Chair and Vice Chair position descriptions to commissioners.

11. Adjournment – With no objections, the meeting was adjourned at 9:57 p.m.
