Approval of Commission Meeting Minutes

Submission of Landlord-Tenant Cases/Scheduling of Cases:

Five new cases were submitted as follows:

<u>Case No. 41016</u>, *Gaynor et al.*, *v Waldrop/Waldrop*. The Commission voted to accept jurisdiction in this case and scheduled the hearing for Wednesday, November 2, 2022

<u>Case No. 44081</u>, *Hu v Dillin Family Trust*. Commission voted to accept jurisdiction in this case and hearing date TBD 2023.

Appeals to Circuit Court:

COLTA Case No. 40810, *Jones v Stephens*. Respondent Kerwin Stephens appealed the Commission's Decision on January 4, 2022 (**Case C-15-CV-22-000001**) but failed to post an appeal bond. A citation was issued on January 21, 2022. The Appeal packet was forwarded to the Court by OLTA on April 12, 2022. On August 1, 2022, the court issued a Show Cause order to Mr. Stephens for failure to file a required brief in this case. On August 26, Petitioner replied to show cause order.

COLTA Case No. 41290, *Casteneda Nassi v Tofigh*. Respondent Seyed Tofigh appealed the Commission's Decision on August 26, 2021 (**Case No. 486935-V**) but failed to post the required bond. A citation was issued on March 30, 2022, and no court date has been set in this case based on Mr. Tofigh's failure to properly serve the Complainant.

Walter presented the County Attorney's position on a question from the panel. A summary of presentation can be emailed upon request. In summary:

- 1. Complaining party has the burden of proof to demonstrate that opposing party violated the law. Ex: If the T disputes that the LL did not send itemized SED letter within 45 days, it's the T's responsibility to provide evidence and persuade the panel.
- 2. Statement of Uncontested Facts/List of Comprehensive Stipulated Facts: If the parties have a list of uncontested facts and it is listed in the case summary, then the Commission should not inquire re: those facts and the Investigator should not include those stipulated terms under question of facts.

The next meeting is scheduled for Tuesday, October 4, 2022 – Mr. Lawrence Cullen will be Chair.
