Programmatic Issues Committee Update (Tracey Clay): This committee has been having conversations on how to best support the child care workforce, specifically noting the tremendous emotional and financial stressors placed on the workforce; concerns that child care providers themselves are facing evictions, homelessness, losses and then coming to work to care for children; considering a way to share resources within the child care community about mental health, food security, rental assistance, etc.
