Updates

- **WPA/Subsidy** (Yvonne Iscandari)
 - o 105 children currently on the WPA waitlist
 - o 78 children pending review for processing eligibility
 - WPA staff have been reaching out to families on the waitlist who have not responded. When asked why they have not responded, there were multiple reasons; e.g. family moved away, too expensive to live in Montgomery County, unemployment, no longer need care, etc.
 - State supplement has been extended to 0-8.

• **Early Childhood Coordinating Council** (Barbara Andrews)

- o ECCC had a meeting on February 21st
- Budget updates provided by Joann Barnes (HHS) and Deann Collins (MCPS)
- Michelle Green reviewed the Office of Legislative Oversight (OLO) reports

• State Early Care and Education Update (Mónica Ortiz)

- HB 0010: Unclaimed prizes state lottery winnings not collected could go toward funding preschool programs throughout the state. The Montgomery County Board of Education is in favor.
- Other bills discussed: HB 0228 (would codify definition of child care—does not seem to be moving forward); HB 0883 (income tax credit for employers that provide onsite child care or provide an employee benefit for employees who pay for child care in other facilities—seems to be moving forward); HB 1415 (Kirwan Commission)

• **County and State Budget Development** (Barbara Andrews)

- FY19 budget to be released on March 15, 2018—every department was asked to put in a reduction budget; Early Childhood Services made reductions to two contracts. There is a County hiring freeze.
- **Office of Child Care** (Carl Eggleston)
 - Staffing and regulation updates (new regulations to be released July 2018)
