Report out from Committee Sessions: Policy Priority Statements:

- Public Policy: Restore WPA funds to prior levels and update subsidy tables to increase reimbursement amounts per family
- Programmatic Issues: Focus on workforce development; restore and increase the County's professional development fund for early childhood and work through the Office of Intergovernmental Relations to implore the Maryland State Department of Education to restore the state child care professional development fund
- Public Policy Subcommittee: Inform county policy makers on issues involving before and after care programming provided by private, public and county programs. The CCC specifically continues to ask:
 - To be included in all meetings related to the CUPF process to reevaluate Executive Regulation 6-17AM
 - For greater transparency in the CUPF selection process
 - For child care professionals to be represented on the selection committee
 - A reevaluation of the principal's role in the selection process

 - Councilmember Jawando recommended that the CCC conduct some type of study to determine "What really are the availability of seats in lower socioeconomic sections of the County"
 - Councilmember Katz: CCC needs to work on forming more of an "ask" as related to the priority areas
