Addendum:

ECE Initiative and County Budget Update (provided by Barbara Andrew)

ECE Initiative: The Community Forum was held on November 25th and even though it was Thanksgiving week there were about 125 people in attendance! After greetings from all of the Executive Group for the Initiative and an overview by JoAnn Barnes, Chief of Children, Youth and Families stakeholders in attendance split into the standing sub-committee groups to provide feedback on draft recommendations and on discussions and considerations developed by the committees. The Initiative Steering Committee is organizing those responses, together with updated recommendations to develop FY 20 recommendations and looking forward any FY21 and FY22 budget recommendations to

share with the Executive Group. Andrew Kleine, the County CAO stayed for the committee work at the forum and listened in at groups to hear the stakeholder feedback.

Maryland Pritzker planning grant and National Governor's Association grant - The planning process for this initial planning grant related to children birth to three, their families and especially children in low income families is nearly complete and the grant application will be submitted in mid-January. If Maryland receives the three year grant the focus will be on strengthening infrastructure to align services, thereby providing more services for children under 3 and living at 200% of the Federal Poverty Line or lower. The grant application addresses child care, Early Head Start, the Infants and Toddler Program, mental health home visiting and consultation and a variety of health concerns. Maryland Family Network and MSDE are leading the process. Barbara Andrews, Monica Ortiz and Charlene Muhammad are assisting with the development of the grant.
