# **Updates on Early Childhood Education Initiative (ECEI) Action Plan (Dr. Barbara Andrews)**

- Creating an RFP for Supply and Demand Study and Market Analysis Study
- Working to create a pilot for subsidy "seats" in child care programs; providers would be paid directly for the seat based on enrollment and not attendance
- Working on pilot to create "seats" for three-year-old children who are aging out of early head start; contract with child care providers to designate subsidy "seats" in programs for these children
- Currently \$500,000/year available for scholarship program at Montgomery College; trying to build the same scholarship opportunities at four-year colleges
- Working on how to build and finance the Kirwan Blueprint

#### Discussion about "Rotating Chair" for reminder of commission year

• In the absence of an elected chair and vice chair, commission members will be asked to serve as a "rotating chair" or meeting facilitator until the instillation of a new chair/vice chair

## • Discussion and Brainstorming for 2021-22 CCC Policy Priorities

# Updates/Report Out

- Yvonne Iscandari, Administrator OESS
  - In November 2021, WPA will increase the income level to 425% of the Federal Poverty Level (from 350% previously)
  - WPA portal is in the Beta testing phase; portal will be in multiple languages and will assist families applying for WPA
  - In future, it is hoped that there will be an "app" for WPA that can link to the local LOCATE
