The Goal


Montgomery County is committed to providing permanent housing to all County residents experiencing chronic homelessness.

Per directive from the U.S. Department of Housing and Urban Development (HUD), for Montgomery County to effectively end chronic homelessness, there should be *no more than three unhoused* chronically homeless individuals or families in the County at any time.

Definition of Chronic Homelessness

- 1. Have a disability, and
- 2. Live on the streets, a safe haven, or in an emergency shelter; or
- 3. Live in an institutional care facility for fewer than 90 days and immediately beforehand have been living on streets, a safe haven, or in an emergency shelter; and
- 4. Have been continuously homeless for at least 12 months or on at least 4 separate occasions (7+ days) in the last 3 years where the combined occasions total at least 12 months.




Housing Placements by Month for Persons who are Chronically Homeless

Total = 369 Placements




Program Type of Permanent Housing Placements



Length of Time Between Assignment and Permanent Housing Placement


Average days between housing assignment & placement for all chronically homeless individuals housed between January 1, 2016 - May 21, 2018




Length of Time that Individuals were Homeless before Permanent Housing Placement




Age of all chronically homeless clients housed & awaiting housing (Total = 384) January 1, 2016 - May 21, 2018




Demographic Information - Gender






