# Bill 7-20 ICH Legislation

- Changes to previous version
  - Allows for designees for the ex-officio positions
  - Broadens language on the hospital representative to include any healthcare provider
  - Adds language on transition plan
- Public Hearing on March 17 at 1:30 PM
- Updates to the Governance Charter needed to reflect new legislation. The revised charter will be submitted to ICH for approval at the May meeting.





# Keys Changes to ICH Membership

- **Local and County Government:** Currently, 7 members are serving in ex-officio seats that would not be specified under the updated statute.
  - *Representation in this category needs to be reduced by 3 Commissioners.*
- **Homeless Service Providers:** Currently, there are 3 Commissioners, representing homeless service providers, but not specifically for the subpopulations identified in the proposed update.
  - *A new process would need to identify 4 Commissioners from organizations providing services to the following subpopulations:*
    - Families with Children
    - Youth
    - Adult households without Children
    - Households at-risk of homelessness and seeking prevention services



# Keys Changes to ICH Membership

- **Private Sector:** Currently, there are no representatives from the private sector.
  - *Four (4) members need to be added from the private sector generally.*
- **General Public** – Currently, there are 3 Commissioners serving under this category that would meet the new requirements for:
  - Person with Lived Experience
  - Residents of Montgomery County (2 current Commissioners)
  - *Three (3) Commissioners would need to be added – one that represents philanthropy, one that represents the healthcare industry, and one being an affordable housing developer.*



# Recommended Next Steps on Member Recruitment

- Any active ex-officio wishing to continue could serve an additional 12-month term
- Any non ex-officio will fulfil their existing term
- A Nomination Committee be established to recruit for both private and public sector members
- In the future, nominations and recruitment will be the responsibility of the Governance Committee





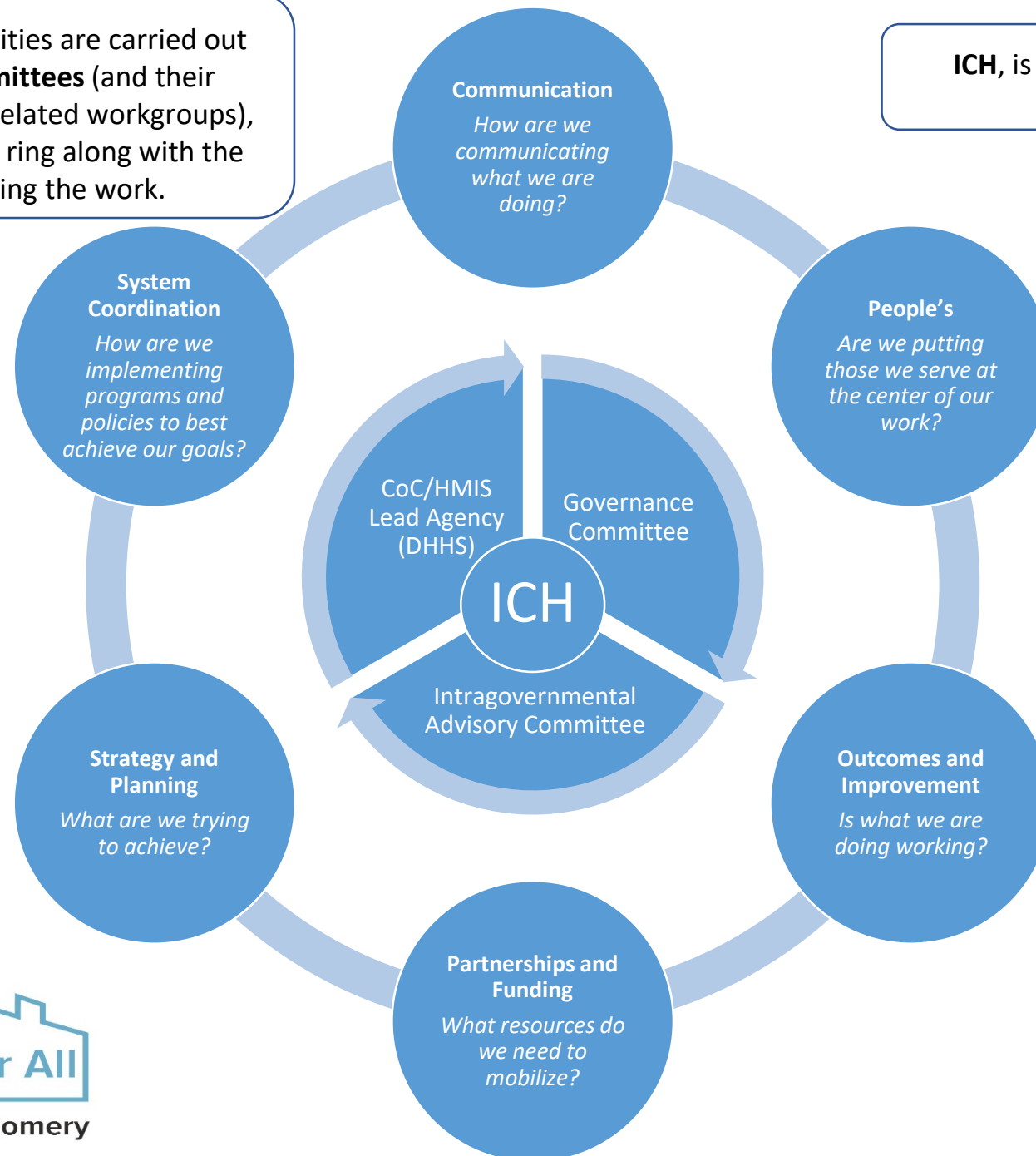
# Committee Structure

Status of Implementation



The CoC's responsibilities are carried out through the **six committees** (and their subcommittees and related workgroups), depicted in the outer ring along with the central question guiding the work.

**ICH**, is at the center of this graphic, representing the primary Governing Body of the CoC.



In the inner circle, the key entities and committees that are charged with ensuring effective governance are depicted. Each one plays a different role:

- The **Governance Committee** ensures that the key discussions are taking place and decisions are being made at the right place and right time necessary to advance ICH's work and fulfill local, state, and federal requirements.
- The **Intragovernmental Advisory Committee** decides who from local government serves on the ICH and meets semi-annually to discuss and exchange information related to current efforts to support the CoC's strategic plans.
- The **Lead Agency (DHHS)** staffs the CoC Governance Structure, providing administrative support, including managing the community's Homeless Management Information System (HMIS).

- **Intragovernmental Advisory Committee** not yet formed due to pending legislative changes to membership.
  - Goal is to stand up this committee by Fall 2020

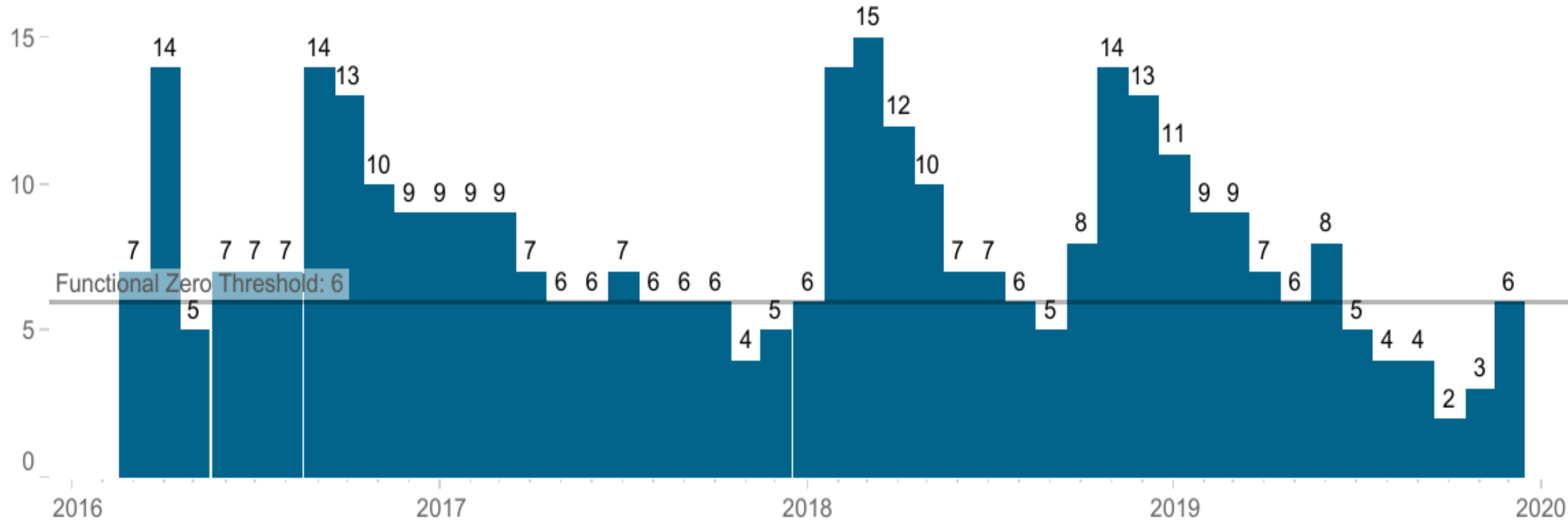

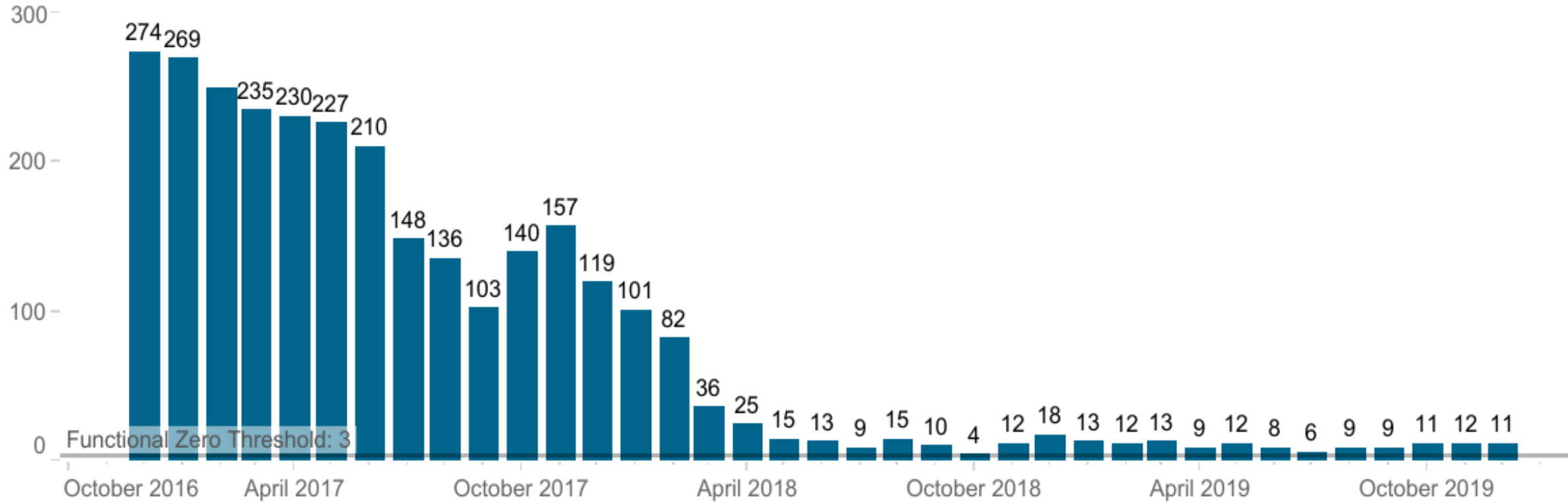
# Status on Zero: 2016 Ending Homelessness for Veterans

## Actively Homeless Population Monthly count for Chronic subpopulation(s)





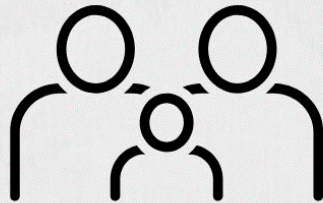
# Status of @ Home Together: Ending and Preventing Homelessness for Families with Children

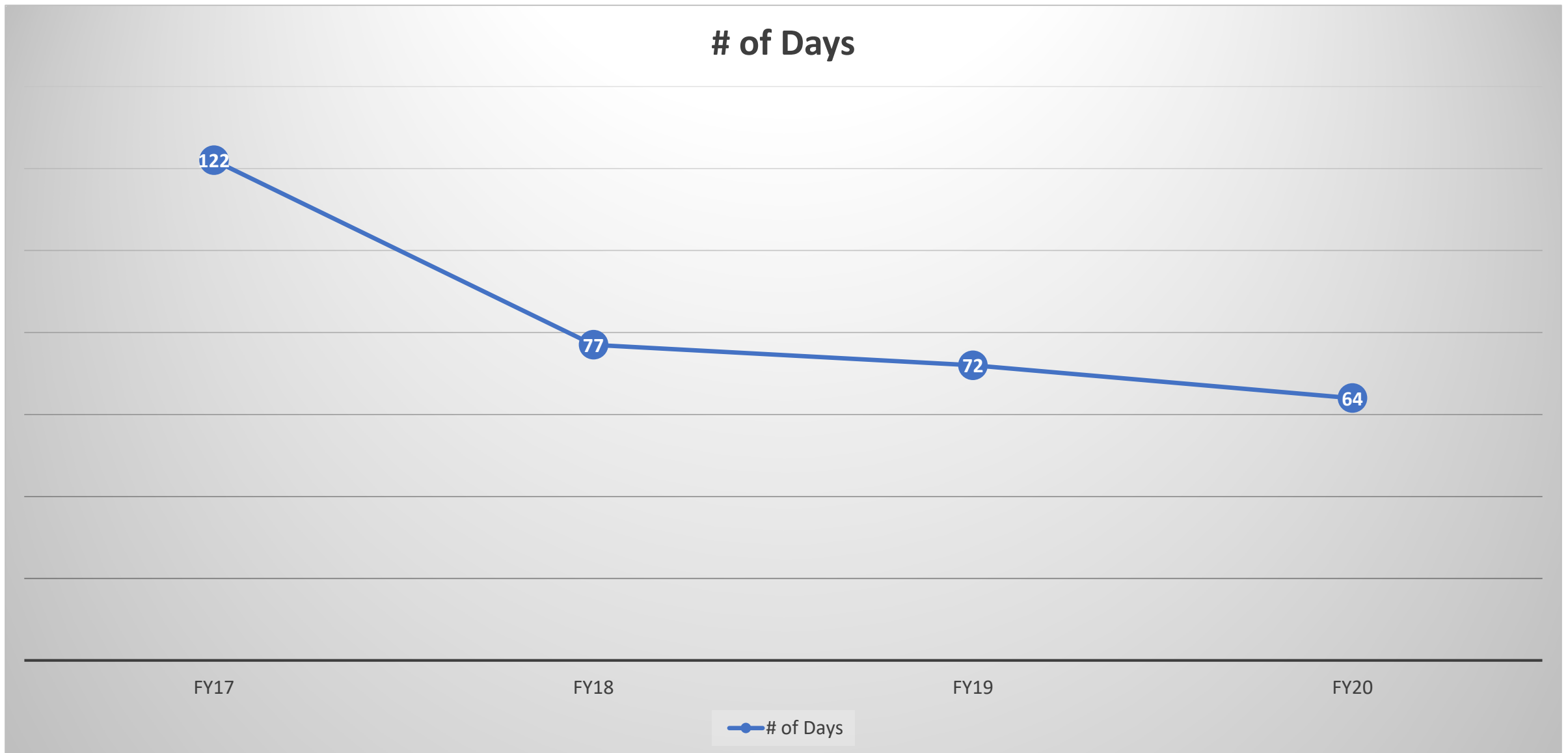

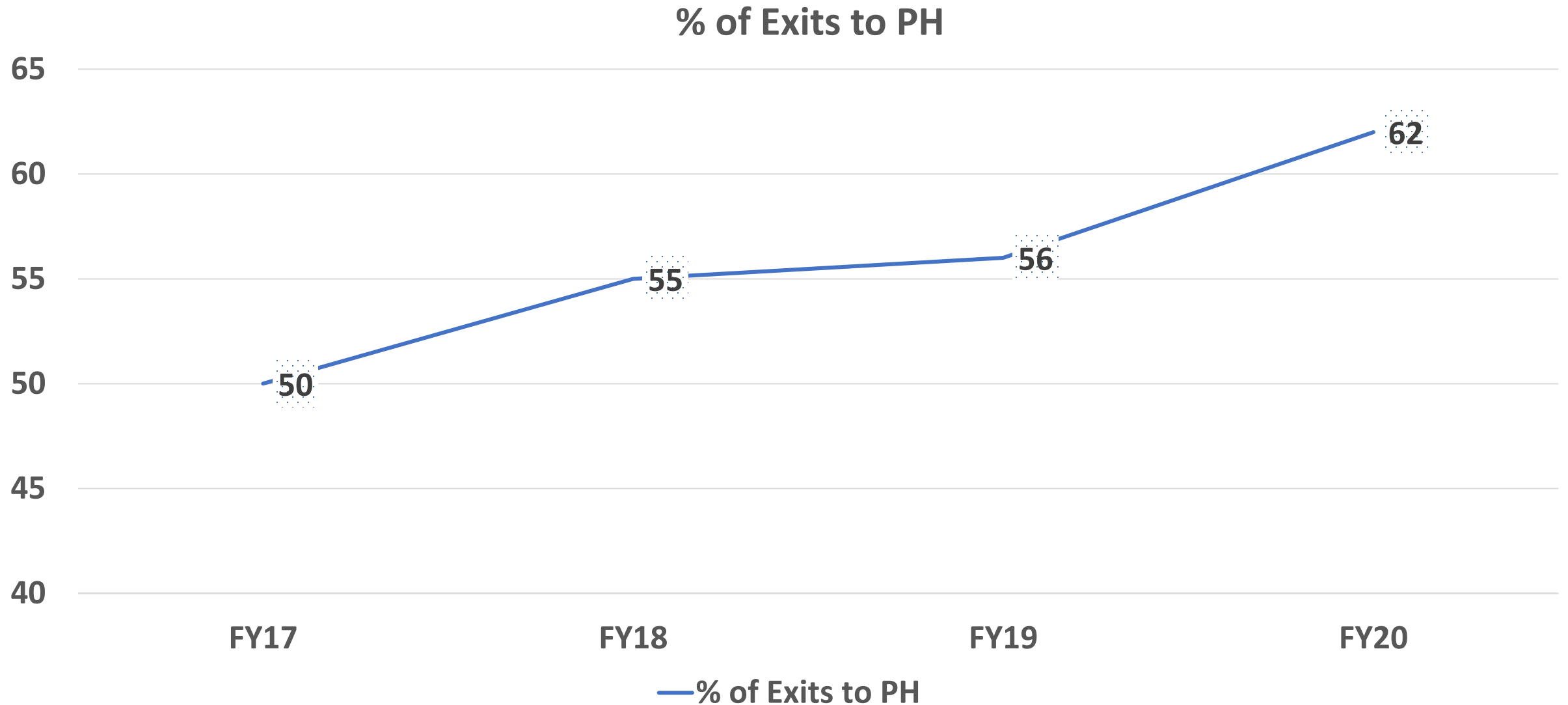
