## ORDER GRANTING CONTINUANCE AND NOTICE OF RESCHEDULED PUBLIC HEARING

Local Map Amendment No. H-117: Soo Lee-Cho, Attorney for Applicant, Wildwood Medical Center, LLC, requests rezoning from the CRT-1.25 Zone (C-0.5, R-0.75, H-50) to the CRTF-1.25 Zone (C-0.5, R-0.75, H-60) of the property located at 10405 Old Georgetown Road in Bethesda, consisting of 3.497 acres in the 7<sup>th</sup> Election District. Tax Account Numbers 07-03669303.

Please take notice that the public hearing on the above-numbered application, previously scheduled to take place on March 3, 2017, has been continued at the request of the Applicant. The public hearing will be held by the Hearing Examiner for Montgomery County, Maryland, in the 2<sup>nd</sup> Floor Davidson Memorial Hearing Room, Council Office Building, 100 Maryland Avenue, Rockville, Maryland commencing on Friday, the 21<sup>st</sup> day of April, 2017, at 9:30 a.m., or as soon after as this matter can be heard.

The Applicant must file any revisions to its application, revised plans, revised statement of justification and revised summary of proof no later than March 21, 2017, to allow the Planning Department's Technical Staff and the public time to review and comment before the newly scheduled hearing date. The Hearing Examiner is approving the requested continuance because the Planning Board's recommendation, which was conditioned upon changes to the Applicant's plans, and the pendency of a draft *Rock Spring Master Plan* covering the area of the subject site, both represent extraordinary circumstances. See Zoning Ordinance §59.7.2.1.C.2 and §59.7.6.2.B.3.a.

The complete files may be reviewed in the Office of Zoning and Administrative Hearings (OZAH), 100 Maryland Avenue, Room 200, Rockville, Maryland 20850, Monday through Friday, between the hours of 9:00 a.m. and 4:00 p.m., prior to the date of the hearing.

Persons or associations that are (1) represented by counsel, (2) intending to appear in organized opposition, or (3) intending to introduce expert evidence or testimony must file a pre-hearing statement containing the information required by Rules 3.4 and 3.5 of OZAH's Rules of Procedure (Rules). Filings must include an electronic copy of the statement and all attachments. These Rules may be found on OZAH's website at <a href="http://www.montgomerycountymd.gov/ozah/">http://www.montgomerycountymd.gov/ozah/</a>. The Applicant must submit its pre-hearing statement at least 30 days before the public hearing. Persons in opposition that are required to file a pre-hearing statement must do so no less than 20 days before the public hearing. The statement must include the following information:

- a statement of the grounds for opposing the application;
- copies of all reports intended to be introduced at the hearing;

- the names of all experts expected to testify at the hearing, their resumes, and a summary of expert testimony which will be proffered at the hearing;
- identity of all other witnesses who will testify; and
- estimated time required for presentation.

In addition to all other requirements, any party submitting documentary evidence for the record must file electronic copies of their submissions. Amended electronic copies must also be submitted of any amended documents. Electronic copies must be submitted on external storage media, including Compact Discs or DVDs, in Microsoft WORD format for text documents, and in PDF format for plans, photos and other non-text documents.

In compliance with Maryland requirements regarding the practice of law, groups or associations must be represented by counsel, unless their witnesses are members of the group or association and will offer testimony in narrative form (*i.e.*, there is no need for an attorney to conduct a direct examination). Nothing in this notice is intended to limit the rights of individual members of the public to testify during the hearing or to submit pertinent written materials at any time while the record remains open for that purpose.

Following the OZAH hearing, the Hearing Examiner will submit a report and recommendation to the County Council, which will make the final decision on this application at a public Council session. The County Council is required to make its decision in a Local Map Amendment case based solely on the evidence in the record compiled by the Hearing Examiner, and on oral argument at a public Council session, if it elects to permit such argument. Neither the applicant nor a member of the community may communicate directly to individual Council members about a pending rezoning case. The law prohibits such direct, private communication because it would not give other parties a fair opportunity to dispute the information provided or to provide contrary information.
