Executive Summary

The project continues to track for an April 2020 substantial completion.

Headliner

Contractor completes Level P2 and moves ahead with construction of Level P1.

Construction of Level P2 was completed this past reporting period, as scheduled.

Level P1


The first pour on Level P1 is scheduled on Friday, September 28, 2018. Level P1 will require ten (10) pours to complete and is expected to wrap-up during the third week of October.

Building Walls

Construction of the building walls will follow construction of the elevated slabs.

Numerous quality assurance/quality control (QA/QC) inspections continue daily to ensure that the concrete, waterproofing, and reinforcing systems have met specified QA/QC requirements. Rigorous inspections are conducted by third-party inspection firms, peer review experts, the contractor, and MCDOT, with oversight by the County's Department of Permitting Services (DPS). Quality is everyone's business!

Utility Construction

Pepco completed the overhead to underground transition this past week and will immediately commence the removal of overhead power lines along the west side of Grandview Avenue expected to be removed by October 6.

Verizon Underground Work

This past week, the work associated with installation of underground conduits for Verizon was delayed by 3-days of rain yet the overall schedule for installation of Verizon underground conduits remain unchanged, as noted below.

Verizon Underground Conduit Installation

Start Date	Location	Time to Complete
September 24, 2018	Grandview Avenue Ennalls to Reedie Drive	3- Weeks to complete.
October 15, 2018	Reedie Drive Grandview Avenue to Triangle Lane	2- Weeks to complete.
October 29, 2018	Triangle Lane Reedie Drive to Lot 13	2-Weeks to complete. Work to be performed at night

Once the underground conduits are installed, Verizon will pull new circuits (communication cables) through the conduits and splice into the existing conduits. The existing overhead Verizon lines will remain overhead on the pole line along Grandview Avenue until such time that all splicing is completed.

WSSC Waterline Relocation

Start Date	Location	Time to Complete
September 24, 2018	Ennalls – Grandview to Veirs Mill Road	4-weeks to complete. Work proposed to be complete at night.

Installation of the waterline along Ennalls commenced and is approximately 40-percent complete.
