SUBJECT: Appointments to the Airpark Liaison Committee

Background

- 1. The Council established the Montgomery County Airpark Liaison Committee by Resolution No. 11-1826 on January 23, 1990, for an 18-month period with the understanding that the Committee would be continued upon a determination by the County Council that continuation of the Committee would be beneficial.
- 2. The purpose of the Committee is to provide a forum for the identification of issues, reconciliation of conflicting views, and communication among interested groups and individuals concerned with the operations of Montgomery County Airpark.
