You have successfully completed your Medical Assistance (Medicaid) Renewal!

What to expect once your renewal is complete:

- ❖ The Maryland Health Connection will send you an eligibility notice stating what program you have been approved for (Medicaid or Qualified Health plan)
- ❖ If your application is completed and verified before your Medicaid expires, you will not receive a new Medicaid or MCO card. Please continue to use your current cards.
- ❖ As long as you apply on Maryland Health Connection within 45 days of receiving your renewal notice, you should be enrolled in either Medicaid or a Qualified Health Plan (QHP) prior to a lapse in coverage.
- ❖ Please call the Medicaid Replacement Card line for any lost or stolen card 1-(800)-492-5231

MCOs- Managed Care Organizations:

- ❖ You have an annual right to change MCOs after you have had your current MCO for 12 months. For more information about how to change MCOs, please contact the HealthChoice line at 1-800-977-7388.

Reporting Changes:

- ❖ You should report changes in your household size, income or contact information as soon as possible to Maryland Health Connection to be sure you are receiving the right amount of tax credit. You can call 1-855-642-8572 (TTY: 8573) or update your online application.

Not reporting changes could mean you will owe the difference when you file your tax return if you are eligible for a lower tax credit.

Examples of a change in household income:

- You get a raise
- You lose your job
- You take a salary cut

Examples of a change in household size

- You get married or divorced
- You have a baby
- You no longer claim your child as a dependent on your tax return
