1. Call to Order

A member of the public expressed dissatisfaction with the Administrative Charging Committee (ACC) section of the 2023 Annual Report and requested an amendment to include additional details.

5. Unfinished Business

Action Item: To send invitations to the Fraternal Operation of Police (FOP), Council, County Executive office (Dr. Stoddard), and other organizations for a "special" meeting to discuss the Freedom of Leave Act views on policy, not legislation. (PAB Staff)

- Dr. Stoddard provided insight to the PAB members regarding Montgomery County FOP Lodge 35.
- The Chair tasked the Vice-Chair and board member Hudson Action are working on drafting an inquiry of detailed request of information needed for the Freedom to Leave Act.

Members continued to discuss the County PAB recommendation to allow access/view of case file details by the PAB of cases adjudicated by the ACC. The PAB Special Legal Counsel researched information about the statute and procedure to collect information with (MPIA) and found the PAB would be custodians of files.

• Members suggested possibly viewing files for situations that include a Police violation and exploring workflow to determine key points that will assist in decisions and form guidelines.

Action Item: The Parliamentarian will draft a template and distribute it to ad hoc (George, Alicia, and Chris) for review to determine the deadline date and share it with PAB members.
