Montgomery County Code 59-C-9.84. Construction Debris Recycling Permit requires that:

- Construction debris be transported to the construction recycling facility in covered "Roll off" containers or covered trucks
- All sorting and processing be done in an enclosed structure.
- When construction debris is separated, collected and processed, an average of 50% of the processed materials by weight have a marketable value.
- Permanent storage is not permitted,
- Fifty-one percent (51%) of the materials processed be collected by the facility operator and
- the total volume of construction and demolition debris collected and recycled be reported to the Division of Solid Waste Services on an annual basis.
