

# The Annual Alcohol License Renewal Period is Here

## Alcohol License Renewal Application:

Renewal applications must be filed with the Board of License Commissioners between February 1, 2025 and March 31, 2025. There is a \$100 renewal fee due with the application. **There is a \$20 processing fee for any submission method other than the online renewal portal.** Choose one of these methods of contactless submission:

- **Best Way – Avoid the processing fee and apply online:** Apply and pay \$100 by credit card through the [online renewal portal](#). Learn how by following [this guide](#).
- Print the [PDF application](#) and mail it with a check or signed ACH authorization form for \$120 to ABS Licensing, 201 Edison Park Drive, Gaithersburg, MD 20878. Envelope must be postmarked by March 31, 2025.
- Email the [PDF application](#) with a signed ACH authorization form for \$120 to [ABSLicensing@MontgomeryCountyMD.gov](mailto:ABSLicensing@MontgomeryCountyMD.gov).
- Mail or email your application and pay \$120 by credit card or ACH through the [self-service payment system](#).

Applications submitted April 1 - April 7 will be subject to a **late fee of \$50 per day**. No applications will be accepted after April 7. If no renewal application is submitted, the **license will expire on April 30, 2025**. Email [ABSLicensing@Montgomerycountymd.gov](mailto:ABSLicensing@Montgomerycountymd.gov) if you do not plan to renew your license.

## Alcohol License Issuance:

After the Board of License Commissioners approves your license renewal on April 10, 2025, you will receive an email with payment options for the annual license fees. If there are no holds or missing items, you will be able to download your license for self-printing. Your license must be posted under glass, in a frame, and readable by the public on May 1, 2025.

## Holds:

These items must be satisfied to receive your alcoholic beverage license:

- outstanding state taxes (contact the MD Comptroller's Office, 410-767-1630)
- any monies owed to Alcohol Beverage Services for product
- any monies owed to the Alcohol Beverage Services, LRE Division, for outstanding fines
- unmet Alcohol Law Education and Regulation Training (ALERT) mandates by the Board of License Commissioners

## Deadlines:

**March 31, 2025:** Last day to **submit the renewal** application

**April 30, 2025:** Last day to **pay for and download** the 2025 alcohol license

**May 1, 2025:** **Post** your 2025 alcohol license under glass, in a frame, and readable by the public
