**SUBJECT: Revision to Board of Appeals Filing Fees**

**Background**


1. Subject to the approval of the County Council, the Board of Appeals may adopt rules of procedure to govern its proceedings. The Board's rules may govern filing fees, the conduct of meetings and hearings, and other procedures necessary to hear and decide cases.
2. The Board of Appeals has submitted for approval a revised fee schedule.
3. The Council approved a revision to the special exception filing fee schedule on June 15, 2010 in Resolution No. 16-1396.
4. On July 13, 2010, the County Council held a public hearing on the proposed revised filing fee schedule.
5. On July 13, 2010, the County Council reviewed the proposed filing fee schedule.
