ACTION ITEMS:

1. Minutes of July 17, 2024, Worksession.

Action: Approved, (RM/CH, 5-0).

2. A-6592, Petition of Tiemoko Coulibaly (Administrative Appeal). Emails to the Board from Dr. Coulibaly, asserting that Ford v. Montana confers jurisdiction on the Board to consider his claims, and providing the Board with a copy of that case. Dr. Coulibaly also asserts violations of due process and of his constitutional rights, and requests that the Board open the record to receive documents. *Located at 2013 Grace Church Road, Silver Spring, Maryland.*
