


# COVID RESPONSE AND RECOVERY

## Regional and National Practice Highlights

Issue 1 - June 17, 2020



With Montgomery County advancing to Phase 2 on June 19, our new-normal harbingers include: resumption of many previously-curtailed RideOn bus routes; new socially distanced outdoor dining opportunities (e.g., Silver Spring's Streetdine, Bethesda's Streeetry); and taming long-neglected tresses. Along the phased recovery pathway, such activities' sustainability depends on dynamic ecosystems of trained personnel and patrons, adequate PPE inventory, potential support through the CARES Act and Montgomery County supplemental assistance; and collaborative, cross-agency focus and commitment.

Such ecosystems are being stood up across the National Capital area and beyond. Accordingly, this newsletter is designed to provide brief highlights of practices in key sectors in Prince George's and Fairfax Counties, the District of Columbia; and in further-afield jurisdictions, too. Select Montgomery County, MD reopening practices may be referenced, starting with subsequent newsletter issues.

Moreover, we now confront an epidemiological convergence of COVID-19 cases' geographic concentration and social determinants of health, atop centuries-long undercurrents of systemic racism. This "environmental agent of disease" must be considered "as a vital sign – alongside blood pressure, pulse, weight, and temperature," the *New England Journal of Medicine* reported June 10. COVID-related resources in this vein may also be shared here, to help support the Council's declaration of racism as a public health crisis. My editorial team of Summer Fellows and I are pleased to present this inaugural issue, and welcome your feedback. -- Lee Rucker Keiser, M.S.P.H.

In the District of Columbia, **guidelines for partitions** were developed to allow for the expansion of child care resources during Phase One of reopening. [Learn more here.](#)

The Department of Human Services in Monroe County, New York has **waived fees for low-income families** receiving subsidies for child care through June 30. This waiver builds on the subsidy program to ensure that families can afford child care in this time. [Learn more here.](#)

Local governments in Westchester County, New York are **directing recovered coronavirus patients to donate plasma at a central extant facility**, the New York Blood Center. Montgomery County, Pennsylvania has started a **weekly "contact-free" food box distribution** at several sites. [Learn more here.](#)




