(Federal Grant)

I am recommending a supplemental appropriation to the FY25 Operating Budget of the UM 3 – Institute for Health Computing Non-Departmental Account in the amount of \$3,000,000. This appropriation is needed to provide a 'pass-through' of a Federal Congressionally Directed Spending/Community Project Funding (CDS/CPF) Grant requested by the County for the benefit and use of the University of Maryland Institute for Health Computing (IHC).

The funds will allow the IHC to purchase advanced computational equipment. The equipment will significantly enhance the speed and breadth of analysis the IHC can provide in supporting its research in the County and in supporting local and regional health, technology and innovation companies. IHC has hired over 70 research and support staff at its North Bethesda location and expects that with these funds it will be able to expand the number of employees to at least 100 within a year. Thus, it will also be able to increase the number of internships onsite and the number of local and regional companies served.

On November 11, 2022, the County signed a Memorandum of Understanding with the three IHC academic partners that, in addition to the mutual financial commitments from the County and the Universities over the ensuing six years, included an intention by the County to seek a Federal earmark for \$3,000,000. The County was successful in its efforts to procure the requested Federal grant and drew down those funds from the Health Resources and Services Administration (HRSA) in December 2024. The terms of the Federal grant provide that the funds

can only be used for the purchase of advanced computational equipment for the benefit of the IHC in Montgomery County.

I recommend that the County Council approve this supplemental appropriation in the amount of \$3,000,000 and specify the source as Federal Grant.

Background

- 1. Section 307 of the Montgomery County Charter provides that any supplemental appropriation shall be recommended by the County Executive who shall specify the source of funds to finance it. The Council shall hold a public hearing on each proposed supplemental appropriation after at least one week's notice. A supplemental appropriation that would comply with, avail the County of, or put into effect a grant or a Federal, State or County law or regulation, or one that is approved after January 1 of any fiscal year, requires an affirmative vote of six Councilmembers. A supplemental appropriation for any other purpose that is approved before January 1 of any fiscal year requires an affirmative vote of seven Councilmembers. The Council may, in a single action, approve more than one supplemental appropriation. The Executive may disapprove or reduce a supplemental appropriation, and the Council may reapprove the appropriation, as if it were an item in the annual budget.
- 2. The County Executive has requested the following FY25 Operating Budget appropriation increases for the Grant Fund:

- 4. The County Executive recommends a supplemental appropriation to the FY25 Operating Budget for the UM 3 Institute for Health Computing Non-Departmental Account in the amount of \$3,000,000 and specifies that the source of funds will be Federal Grant.
- 5. Notice of public hearing was given and a public hearing was held.
