Call to Order and Attendance (6:31 PM)

 Chair Bellamy called the meeting to order at 6:33PM. A quorum of ACP members was present.

Approval of Draft Minutes, May (6:31 PM)

Compliance Subcommittee (6:32 PM)

- Status Report to Commission
 - Mx. Quittman reported on the subcommittee's work. The subcommittee met 3 times over
 the past several weeks to review the 87 recommendations from the Reimagining Public
 Safety Task Force report and to develop questions for relevant agencies regarding
 implementation. The subcommittee is working on a document to provide feedback on the

- recommendations and plans to go through this process again for the Effective Law Enforcement for All (ELE4A) audit.
- VOTE: Mr. González moved and Mr. Mulzac seconded the motion that the ACP endorses the
 work of the subcommittee and looks forward to the finalized set of questions to transmit to
 the various agencies through staff, and also that the subcommittee continue working on the
 other reports and continue updating the commission on its work. Motion passed
 unanimously.
- Proposal for two new subcommittees: Data & School Safety
 - The ACP formed two new subcommittees with membership described below:
 - o Data Subcommittee: Mr. George, Mr. González, Mr. Blair, Mr. Watson, Mr. Mulzac
 - o School safety: Dr. Walsh, Ms. DeLane, Mr. Watson, Chair Bellamy, Mx. Quittman

Draft Annual Report (6:57 PM)

- The Commission reviewed the draft of the annual report prepared by Mr. González and Dr. Walsh. Commissioners had no additional comments or edits.
- **VOTE**: Mr. Watson moved and Mx. Quittman seconded approval of the report as prepared. The motion passed unanimously.
- **ACTION:** Council staff will finalize for publication.

Draft Work Plan (7:01 PM)

- The Commission reviewed the draft work plan prepared by Mr. González.
- The Commission made revisions to the plan as follows:
 - Adding the phrase "community-centered" to the Goal section
 - o Indicating next to each strategy in the workplan the subcommittee, if any, that is responsible for that item.
 - Revising the language in strategy #3 and strategy #5 to reflect the ACP's role with regards to MCPD's processes.
 - Removing strategy #7 with the understanding that the focus on considering MCPD peer jurisdictions is already captured by strategy #1 (by formal unanimous vote).
- The Commission discussed strategy #8, "review the role of police in the probable cause and pretrial release decisions of District Court Commissioners."
 - VOTE: Mr. González moved and Mr. Mulzac seconded the creation of a subcommittee to review information pertinent to this strategy, including from MCPD and the State's Attorney's Office as appropriate. The subcommittee would include at least Mr. Mulzac, Mr. González, and Ms. Branson. The motion passed unanimously.
- **VOTE**: Mr. González moved and Mr. Mulzac seconded approval of the work plan as amended for inclusion in the annual report. The motion passed unanimously.
