I asked the person in front of me, "why is no one using the other stall," to which she replied, "it's broken." I waited for my turn to use the singular functional toilet and began contemplating if I should still wait, knowing it was taking time away from my classwork. 10 minutes later, it was my turn to use the bathroom. As I came out to wash my hands, I heard a blaring noise from the faucet, along with its vigorous rattling. Additionally, I tried to wash my hands with no hot water or soap.
