Testimony to Montgomery County Council Supplemental Appropriation #24-67 in the FY24 Operating Budget, \$260,000 for BlackRock Center for the Arts Position: Support

Good afternoon Council President Friedson and members of the County Council. Thank you for the opportunity to share the Gaithersburg-Germantown Chamber's support for supplemental appropriation #24-67 in the FY24 operating budget for BlackRock Center for the Arts. I am Paula Ross, President & CEO of the Gaithersburg-Germantown Chamber of Commerce. BlackRock is a valued member of the Chamber and an important partner in our Chamber's community engagement programming in the Upcounty.

BlackRock sits in the Town Center of Germantown and while it is an incredible hub for arts and culture experiences and education, it is so much more than that. BlackRock has grown to be the community gathering center in the Upcounty. When the Council needs a space to conduct a town hall in the Upcounty, they call BlackRock. When the Chamber needed a place in Germantown to host a Coffee with a Cop event to convene residents and public safety officials for important conversations, BlackRock offered its space. When there is a need in the community, BlackRock opens its doors, such as during the pandemic when the center became a hub for food distribution to those community members in need. Community groups convene at BlackRock for meetings, neighbors gather at BlackRock to share a movie on the lawn or to see Santa, the business community comes together with neighbors at BlackRock at markets held on the lawn during nice weather.

You might know that the GGCC will be conducting a feasibility study in Germantown Town Center, the goal of which is to assess the viability of creating a sustainable Business Improvement District or Urban District. BlackRock is at the heart of that plan, both as a geographic partner and economic development convener. BlackRock will help us bring the business community and residents together in support of the economic development that was planned in Germantown but never yet realized.
