What is the Montgomery County Council?

The County Council is the legislative branch of County government. They make legislation, approve budgets, and decide what type of buildings can be built in and around your neighborhood.

How Does a Bill Become a Law?

A bill begins with an idea and goes through a series of stages to evaluate, amend, and take a vote by legislators, or, in this case, your Councilmembers. Here is how a bill moves through the legislative process at the Council:



1. Development Stage

One or more Councilmembers takes an idea and develops it into a bill.

2. Introduction Stage

The bill is introduced during session and assigned to a Committee for review.

3. Public Hearing Stage

Community members have the opportunity to weigh-in on a bill.

4. Worksession Stage

Councilmembers work together to finalize the bill.

5. Vote Stage

Councilmembers vote on the bill. If passed by a majority of votes, the County Executive signs or vetoes it.

6. Implementation Stage

If a bill is approved, departments will then work to implement what the law says.
