## **AN AMENDMENT** to the Montgomery County Zoning Ordinance to:

- revise the uses for a dish antenna; and
- revise the use standards for antennas on existing structures that include a broadcast studio

By amending the following sections of the Montgomery County Zoning Ordinance, Chapter 59 of the Montgomery County Code:

Division 1.4. "Defined Terms"

Section 1.4.2. "Specific Terms and Phrases Defined"

Division 3.5. "Commercial Uses"

Section 3.5.14. "Accessory Commercial Uses"

## OPINION

Zoning Text Amendment No. 17-11 was introduced on October 10, 2017. It would allow a dish on an existing structure with a broadcast studio to be 22 feet in diameter.

In its report to the Council, the Montgomery County Planning Board and Planning Department staff recommended approval with an amendment to include a definition of "Media Broadcast Studio".

The County Council held a public hearing on November 14, 2017 to receive testimony concerning the proposed text amendment. In addition to the testimony of the Planning Board representative, Bob Harris spoke in favor of approving ZTA 17-11. The Director of the Department of Technology Services, Sonny Segal, was scheduled to speak at the hearing on behalf of the County Executive. In written testimony, he wanted to ensure that these large rooftop antennas are compatible in urban areas and suggested that larger antennas only be on buildings that are at least 200 feet tall.

The text amendment was referred to the Planning, Housing, and Economic Development Committee for review and recommendation.

The Planning, Housing, and Economic Development Committee held a worksession on November 11, 2017 to review the text amendment. After careful review of the materials of record, the Committee recommended that ZTA 17-11 be approved with the definition of Media Broadcast Studio recommended by the Planning Board. The Committee was not persuaded that larger antennas should be restricted to buildings 200 feet or taller.

The District Council reviewed Zoning Text Amendment No. 17-11 at a worksession held on December 5, 2017. The Council agreed with the Committee's recommendation to approve ZTA 17-11 as amended.

For these reasons, and because to approve this amendment will assist in the coordinated, comprehensive, adjusted, and systematic development of the Maryland-Washington Regional District located in Montgomery County, Zoning Text Amendment No. 17-11 will be approved as amended.
