- III. Introductions of WQPC Members
- IV. New Business
 - a. A presentation was given by Dr. Dann Sklarew, Professor of Applied Ecology and Sustainability Sciences, George Mason University, on the Effects of Climate Change on the Tidal Potomac River. The presentation focused on trends in various water quality indicators including water clarity (hypereutrophic), phosphorus (eutrophic), nitrogen (hypereutrophic), algal bloom density (mesotrophic), maximum algal density (eutrophic or worse), and carbon production (not known and to be determined). Dr Sklarew noted that algal blooms have not been adequately limited by the investments made so far in reducing nutrient pollution and that algae will likely increase with higher temperatures due to climate change. In addition, erratic rainfall events and increasing temperatures will create more drought conditions that will foster harmful algal blooms. There is a need to better understand microbial responses to climate change factors. Dr. Sklarew also noted that there is a need to remove disincentives to more efficient circular economies for nutrients. His presentation is included with the meeting notes.
