2. Erika Bucciantini asked why 650k bag cap? Jane Hunter said in the past bags fell apart and made a mess. Current bags hold their integrity for years. SCA may consider removing bag cap. DAFIG to consider advising County Executive to increase bag limit.
 3. Jane Hunter asked about \$28 Mil Composting Capital Improvement Project (CIP) approved by County Council. Traffic impacts?

 - i. Westland Ash Landfill (Maryland Ash Management, LLC.)
 1. Q3 Westland Ash Landfill report 250909, posted to DAFIG webpage.
 2. 92,644 tons of Fly Ash removed in 2025. (Through July 2025).
 3. 1,013,887 tons of Fly Ash removed since the project started. (Through July 2025).

 - ii. Terra Energy, LLC revising Concept Plan for submittal to County as part of Conditional Use. Expected timeline next month.
 1. Battery Energy Storage Systems (BESS). Land Bay #2, 35 acres. Now using LG product, not Tesla.
 - a. Start construction Fall 2026.
 - b. Phase #1 300MW open 2028.
 2. Data Centers still in planning stage.
 - a. Load Study coming soon.
 - iii. Jeff will hold Town Hall meeting soon.
 - iv. Jeff will notify DAFIG of any upcoming Hearings.
