

**THIRD AMENDMENT TO LICENSE AGREEMENT**

This Third Amendment to License Agreement ("Third Amendment"), being made this 21<sup>st</sup> day of November, 2006, between **MONTGOMERY COUNTY, MARYLAND**, a body corporate and politic and a political subdivision of the State of Maryland, (hereinafter designated as the "COUNTY") and **WASHINGTON D.C. SMSA LIMITED PARTNERSHIP d/b/a Verizon Wireless** with principal offices at One Verizon Way, Basking Ridge, NJ 07920 (hereinafter designated as the "LICENSEE"). (LICENSEE and COUNTY, together, the "PARTIES".)

**WHEREAS**, the COUNTY and LICENSEE entered into a License Agreement dated February 19, 1997 for property located at 12100 Darnestown Road, Gaithersburg, Maryland (the "Agreement"); and

**WHEREAS**, the COUNTY and LICENSEE entered into an Amendment to License Agreement dated February 25, 2002 (the "First Amendment"), and entered into a Second Amendment to License Agreement dated August 26, 2003 (the "Second Amendment"); and

**WHEREAS**, a copy of the Agreement, First Amendment and Second Amendment are attached hereto and made a part hereof; and

**WHEREAS**, the PARTIES desire to extend the term of the Agreement, and to adjust the rental terms.

**NOW THEREFORE**, in consideration of the premises and intending to be legally bound hereby, the PARTIES hereto agree to the following changes and modifications to the Agreement.

1. **TERM EXTENSION:** The term of this Agreement extension shall be five (5) years to commence on March 1, 2007, and expire on February 28, 2012. The PARTIES acknowledge that first day of the extension term is being adjusted to commence on the first (1st) day of the month, and LICENSEE waives any interest in the overlapping rental payments for a portion of March 2007.

2. **RENTAL ADJUSTMENTS:** It is agreed between the PARTIES that the annual rent payable by LICENSEE to the COUNTY is as set forth in the following schedule:
