Approval of Commission Meeting Minutes

Submission of Landlord-Tenant Cases/Scheduling of Cases:

Five cases were submitted as follows:

<u>Case No. 40298, Bowman v Sohrabi</u>. The Commission voted to accept jurisdiction in this case and the hearing was scheduled for Tuesday, January 17, 2023
