### **Approval of Commission Meeting Minutes**

## **Submission of Landlord-Tenant Cases/Scheduling of Cases:**

The Commission voted on whether to accept jurisdiction on the following case submitted:

Case No. 48570, *Harrison v Kushawaha* - The Commission voted to accept jurisdiction in this case, however; since the investigator was not available, no hearing date was set or panel assigned. One Commissioner recused themselves from the vote or any comments as they knew the Respondent.

Case No. 48939, Walker v FPA/WC Wheaton Station, LLC – The Commission voted not to accept jurisdiction in this case and it was dismissed. The vote was seven Commissioners voted not to accept jurisdiction, three Commissioners voted to accept jurisdiction and one Commissioner recused themselves from the vote or any comments as they knew the Respondent. The case was dismissed on a 7 to 3 vote.
