SHADY GROVE ROAD RESURFACING PROJECT

Gaithersburg, MD

PURPOSE

This newsletter is to inform you of the upcoming resurfacing of Shady Grove Road, from Frederick Rd. Rt. 355 to I-270 Bridge. Please see the reverse side of this newsletter for the project map. This project will consist of base repairs, utility adjustments, and roadway resurfacing. The impact of traffic will be at minimum. This pavement system preservation project employs long term strategies to improve roadway conditions.



IMPACTS

Parking signs may be posted in advance. There will be lane shifts and lane closures. We will do our best to keep impact to traffic at a minimum. Please walk & drive carefully through the work zone and obey all posted signage. We thank you for your cooperation and patience as we work to improve the County infrastructure for residents and users.



SCHEDULE

This project is scheduled to start on June 15, 2025 and will take roughly 4-6 weeks to complete, weather and other operational requirements permitting. Work hours will be between 8:00 PM and 6:00 AM Monday through Friday.




