Convene the Board of Canvassers Meeting and Declare a Quorum Present

Mr. Shalleck called the Board of Canvassers meeting to order and declared a quorum present at 2:30 p.m.

Mr. Shalleck noted that Board member, Ms. Phillips, was attending via phone.

Mr. Shalleck publicly thanked Ms. Jurgensen and staff for all their effort, hard work and commitment to the election process.

Certification of the 2018 Primary Gubernatorial Election (Incorporated as Attachment A)

Ms. Jurgensen reported that the audit of the June 26, 2018 Gubernatorial Primary Election has been completed. Ms. McLaughlin added that the Board of Elections submitted images of the ballots to Clear Ballot (the vendor selected by the State, which performs an independent audit of the images) to re-tabulate the ballots, noting that the re-tabulation was well within the margin of voter error. (According to the Clear Audit software audit, Roger Berliner and George Leventhal each should have received one more vote for the County Executive nomination, and Ariana Kelly and Sara Love should have received one more vote each for the District 16 Delegate nomination). Therefore, there were no material differences in the results certified by the Board. Mr. Shalleck requested that the results be provided (staff noted that the audit results were available on the SBE website and circulated printed copies). Mr. Karpinski noted that the State Board of Elections provided a webinar to the representatives of the Blair, Elrich, Love and Paul campaigns explaining how the Clear Ballot process works and they were also provided access to ballots to evaluate any potential challenges.

Challenges (Detailed information will be provided in the Canvass Minutes)

Mr. Karpinski and Ms. White researched information for the Board of Canvassers in order to review challenges to rejected provisional ballots submitted by the Blair campaign, Elrich campaign and Paul campaign. In total, 29 challenges of 28 ballots were heard by the Board of Canvassers. After reviewing the challenges and additional information provided by the staff, the Board of Canvassers moved to change its decision to reject 2 of the ballots in question. The Board moved not to change their decision during the canvass for the other 26 ballots. (A unanimous vote by the Board is necessary to reject a voter's ballot.) The 2 ballots that were overturned were counted and included in the Official Election Results. Almost all the Board decisions were unanimous. However, in a number of situations, Ms. Keefe, Mr. Naimon, and Mr. Banov abstained because it seemed that the rejected voters could have cast valid ballots but for mistakes by the MVA, including several instances in which the voters swore that they registered at the MVA, but the Board had no record of it. (The issues registration changes which MVA was supposed to process, but did not transmit to the Board of Elections. As a result, citizens who tried to vote were not registered and therefore could not cast regular ballots in the primary.) The Board requested that staff write letters to those voters whose ballots were rejected based on MVA issues. Mr. Shalleck, Mrs. Khozeimeh, and Ms. Phillips voted to uphold the staff's recommendation based on the official records available to the staff.

The Board continued to express concern with how MVA processes voter registrations, which have resulted over the years in unwanted party affiliations, inaccuracies in citizenship, and voters claiming they registered at MVA, but where there is no record of registration, all resulting in rejected provisional ballots. Ms. McLaughlin reminded the Board that they had previously initiated a request for a legislative audit of MVA processes, which was not conducted but which did trigger some changes at the MVA. Mr. Karpinski noted that the voter has the ability to appeal the rejection of their ballot to SBE. The Board requested that Mr. Karpinski prepare a letter to be distributed amongst the Board and other jurisdiction regarding the Board's concerns about MVA.

The Board requested that the staff send a letter to those voters whose ballot was challenged by a campaign and not overturned by the Board, advising them of the opportunity to appeal to the SBE.

Ms. McLaughlin shared with the Board the audit findings requested earlier in the meeting. She noted that the audit findings could also be found on the SBE website. She briefly described the items on the report, noting that the audit is conducted by Clear Audit, on the Clear Audit system, comparing the differences on the how the system viewed the image differently than Election Systems & Software (ES&S) Mr. Shalleck requested that Ms. McLaughlin share the findings for the Legislative District 16 and the County Executive Democratic Primary Elections. Mr. Karpinski noted that the audit findings change nothing, as the Clear Ballot was not used to tabulate votes.

The Board agreed to recess the meeting to await the updated certification documents.

Ms. Khozeimeh moved to recess the Board of Canvassers meeting at 3:56 p.m. to await the updated certification documents. The motion was seconded by Ms. Keeffe and passed unanimously.

Ms. Khozeimeh moved to go into the regular Board Meeting at 3:56 p.m. The motion was seconded by Ms. Keeffe and passed unanimously.

Convene the Board Meeting

Mr. Shalleck called the Board meeting to order and declared a quorum present at 3:56 p.m.

Approval of the June 18, 2018, Board Meeting Minutes

Mrs. Khozeimeh moved to accept the June 18, 2018, Board Meeting minutes as amended. The motion was seconded by Ms. Keeffe and passed unanimously.

Approval of the June 26, 2018, Board Meeting Minutes

Mrs. Khozeimeh moved to accept the June 26, 2018, Board Meeting minutes as amended. The motion was seconded by Ms. Keeffe and passed unanimously.

Approval of the July 4, 2018, Board Meeting Minutes

Mrs. Khozeimeh moved to approve the portion of the May 21, 2018 minutes that were submitted by Lisa Merino, as amended. The motion was seconded by Ms. Keeffe and passed unanimously.

Approval of the June 18, 2018, Executive Session Minutes

The Board will hold off on the June 18, 2018, minutes since they were not provided in advance.

Approval of the July 4, 2018, Executive Session Minutes

The Board will hold off on the July 4, 2018, minutes since they were not provided in advance.

Additions/Changes to the Agenda

Mr. Shalleck stated there will be an Executive Session at the end of the regular meeting to discuss a confidential voter request and a security issue.

Public Comments

Dolly Kildee represents the Democratic Central Committee as liaison to the Board. However, the issue she has today is not from them. Ms. Kildee provided comments about the lack of handicap parking at the lower entrance at Gaithersburg High School, where voters enter. Ms. Kildee added that voters were directed to a lower parking entrance, where there was no handicap parking. She added that there was handicap parking located at the upper entrance. The Board thanked Ms. Kildee for her comments and requested that staff investigate the issue.

Election Director Status Report (Incorporated as Attachment B)

Personnel

Ms. Jurgensen stated that there has been no change in personnel. Personnel are being held to assist with the recounts.

Budget (Incorporated as Attachment B)

Ms. Roher stated that the budget spreadsheet detailing the final FY18 expenditures was sent in advance and is dated through June 30. Ms. Roher noted that the spreadsheet reflects the payroll only through July 9, but does include all payroll covering Election Day, Early Voting and the beginning of the canvass period, which will include an extensive amount of overtime.

Voter Registration

Ms. Jurgensen indicated that Voter registration remains closed until the Election is certified. The State has notified the staff that they will re-open the books tomorrow. She added that the State Board of Elections will meet on July 19, 2018, to certify the Maryland State Election.

State Board of Elections

Ms. Jurgensen stated that there is nothing further to report at this time.

Board Attorney Report

Nancy Floreen Candidacy

Mr. Karpinski stated that Councilmember Nancy Floreen has filed a declaration of intent to run as an unaffiliated petition candidate for County Executive. An issue was brought to his attention on election night by the attorney for the Prince George's County Board of Elections. The attorney requested Mr. Karpinski to read the section of declaration of intent statute requiring a candidate to be of that party. Mr. Karpinski stated that the most logical interpretation is that you have to be unaffiliated as of the time that you file your certificate of candidacy, which is due the first Monday in August, which also happens to be the deadline for filing the petition to become a candidate. Mr. Karpinski added that the Board of Elections received a declaration of intent from Ms. Floreen and noted that there is no action needed by the Board members. Ms. Floreen has requested an advance determination for the form of her petition, which is reviewed by the Election Director. Mr. Karpinski stated that he has reviewed the petition and agrees that it meets all of the requirements. A letter will be sent to Ms. Floreen's her representative stating that her advance determination is complete, and the petition format meets the standards. Mr. Karpinski stated that Ms. Floreen would need to get 1% of valid signatures from inactive and active registered voters in Montgomery County. The deadline for her to submit the signatures is August 6th. She is required to submit at least 7,244 valid signatures that meet the state's requirements.

Old Business

Ms. Phillips requested that Mr. Karpinski prepare a letter (to be reviewed by the Board) to the State noting all the concerns that the Montgomery County Board has about the MVA

processes. The letter needs to be circulated amongst the Board chairs of the five other large counties for their comments.

2018 Gubernatorial Primary Election Preparation

Board Member Observation

Observations will be discussed at a future Board meeting.

Ms. Jurgensen requested that Board members provide any specific issues to her. The Board members agreed to submit their observations or concerns encountered during the Primary Election via email so that staff has an opportunity to review and comment at a future meeting.

Board Attorney Observation

Observations will be discussed at a future Board meeting.

New Business

Mr. Banov suggested that the Board write the State Board to ask it to change the provisional ballot application. Currently, it invites the voter to request a ballot for whatever party she/he wants, but the form should state: "In accordance with my registration, I would like a _____ ballot." The Board agreed with the suggestion.

Ms. Ross provided the provisional elections results for signature by Mr. Shalleck and Ms. Keeffe prior to the printing and presenting of the certification documents.

Precinct 04-17, Kennedy Shriver Aquatic Center

Ms. Keeffe stated that the Kennedy Shriver Aquatic Center was a temporary location for precinct 04-17 (as its normal location at Luxmanor Elementary School is being renovated), but offered a very small space for voting and no place for staff to eat. Due to very confining space limitations, she recommended that precinct 04-17 location be moved. Mr. Naimon agreed with Ms. Keeffe and added his comments about the inadequate space for the judges and the stress they were under. He added that he knew we ordinarily doesn't support moving polling places between the primary and the general election, but thinks it is warranted in this case, urging that the precinct vote at B'Nai Israel Congregation in the General Election. Ms. Jurgensen stated that staff was able to speak with representatives at B'nai Israel Congregation and the location has been reserved for use in the General Election.

Mr. Naimon moved to use B'nai Israel Congregation for precinct 04-17 for the 2018 General Gubernatorial Election. The motion was seconded by Ms. Keeffe and passed unanimously.

The Board members discussed the likelihood of recounts and Board members' availability.

Future Meetings

The next Board meeting will tentatively be on August 20, 2018, subject to the need to meet to certify any new primary results.

Mr. Shalleck requested that the Board meeting break as the certification documents are prepared, the Board agreed. The Board took a break at 3:58 p.m.

Upon the return of the Board meeting, *Mrs. Khozeimeh moved to go into Executive Session at 4:52 p.m. The motion was seconded by Ms. Keeffe and passed unanimously.*

Report on Executive Session

The Montgomery County Board of Elections convened in Executive Session at 4:52 p.m., pursuant to General Provision Article section, 3-305(a) (13), to discuss the future fiscal impact for 2020.

The Montgomery County Board of Elections met in closed session on this date. The following members of the Board and staff were in attendance: Jim Shalleck, Nahid Khozeimeh, Mary Ann Keeffe, David Naimon, Jacqueline Phillips (via phone), Alan Banov, Kevin Karpinski, Margaret Jurgensen, Alysoun McLaughlin, Lisa Merino and Marjorie Roher.

The Board discussed the fiscal year impact for 2019 and the Board's salary.

Mrs. Khozeimeh moved to close the Executive Session and reconvene into the regular Board meeting at 5:11 p.m. The motion was seconded by Ms. Keeffe and passed unanimously.

Board Meeting

Mrs. Khozeimeh moved to increase the Board members' and substitute members' salaries (for the Board that takes office in June 2019) by \$500, to increase the Board's canvass stipend by \$250, and to request an additional \$107,370 in the budget for various items, as discussed with the Board in Executive Session. The motion was seconded by Ms. Keeffe and passed unanimously.

New Business

Mr. Shalleck revisited the new business item.

Mr. Naimon stated that Mr. Banov recently noticed that a school (the Avalon School) is moving into the St. Catherine Laboure building. Mr. Naimon expressed concern with the building being used as an Early Voting site while being used as a school that is in session, and that some

Board members had not been notified of this change, and it wasn't mentioned at the Board's May or June meetings.

Ms. Keeffe spoke to the issue, saying that Mr. Naimon had never been much in favor of the site. She said that the school would not impact the building's use as an Early Voting site. She stated that before the Primary she had been aware the building would be used as the school and discussed it with staff, and noted that staff immediately followed up with the Pastor. She also said that the room was perfect for early voting, and there was no real alternative in the Wheaton area. She said that she didn't think it was a concern for the whole board, as we don't really discuss individual voting sites when there's a little tweak to them. Mr. Naimon said he thought this wasn't a tweak. He stated that he voted in favor of the site, did everything possible to support it, and put in the record the reasons why the nearby alternative public site was inadequate in order to support having this site. He continues to support the site today. He expressed his concern that the information about changes to the site was not shared equally with all Board members. He expressed concern that the school would be in session while the building would be used during Early Voting. He pointed out that Montgomery County Public Schools have been closed on election days since he was in elementary school, to avoid the problems caused by having school and elections at the same time. He said the Board should have been informed about this. Mr. Banov inquired if the room used for Early Voting would be used by the school and if renovations would be in progress prior to the General Election. Ms. Keeffe stated that it is her understanding that the room used for Early Voting will be designated for Early Voting only and upgrades will be done to the building. Mr. Banov stated that he and Mr. Naimon share the concern that religious crosses would be added to the room. Mr. Naimon commented that this is not an issue of Mr. Banov's and his personal views, but that some voters would not be religiously permitted to vote in a room that contained religious symbols from other religions. Ms. Rzeszut stated that this issue has not come up in discussions with Avalon School, but that no icons or religious crosses will be added to the Claridge room (used as the Early Voting room) as a result of the renovation in the building. Mr. Naimon inquired whether the arrival of the school would impact parking and electioneering boundaries. Mrs. Rzeszut stated that arrangements have been made for staff parking and that electioneering boundaries would not be affected. Ms. Rzeszut also said that some spaces would need to be left open for recreation during the day for the students. Mr. Naimon inquired if any of the contract language with the church has changed since we became aware of the school moving into the space. Mrs. Rzeszut stated that there have not been any changes. Mr. Naimon expressed surprise that we were discussing the situation with another lessee of the property who is signing a lease after we did, rather than with the church, who is the owner of the property. Mr. Karpinski stated that he has not been privy to these discussions and he would be more actively involved in the future. Mr. Naimon said that he believed that if there is a disagreement between the school and the Board, it becomes an issue for Mr. Karpinski to discuss with the church, and Mr. Karpinski agreed. Ms. Keeffe said that there isn't anything to her knowledge that the school is talking about that is contrary to our contract with the church.

Board of Canvassers

Ms. Jurgensen presented four copies of the 2018 Primary Gubernatorial Elections certification documents to the Board of Canvassers for signature. (A copy of the certification document is attached to the minutes.) The documents were signed by Mr. Shalleck and Ms.

Keeffe, and a copy was distributed to the public. Once signed, Ms. Merino will provide a copy to the State Board of Elections.

Mr. Banov moved to certify the 2018 Primary Gubernatorial Election results for Montgomery County. The motion was seconded by Mrs. Khozeimeh and passed unanimously.

With nothing further to discuss, Ms. Khozeimeh moved to close the Board Meeting and the Board of Canvassers meeting at 6:15 p.m. The motion was seconded by Ms. Keeffe and carried unanimously.
