[0:25] Convene Board Meeting and Declare Quorum Present

Mrs. Khozeimeh convened the meeting.

President Remarks

Mrs. Khozeimeh requested that Mr. Karpinski go over all the precinct changes for redistricting and that the Board vote on them if necessary.

[0:44] Public Comments

Mrs. Merino-Dean mentioned that Ms. Aneshell Miller requested to address the Board in advance, but was not present when called upon.

[4:47] Redistricting

Mr. Karpinski noted that the best way to vote on the precincts was to go through the [Redistricting Worksheet – Preliminary Staff Recommendations], found here. Mr. Karpinski asked the Board to express their concerns and ask questions about any particular precincts so that they could. Mr. Karpinski noted that the last day to make approvals is May 3, 2022.

[5:54] 01-01A – Mr. Naimon asked about the reason for moving 202 voters from 1-1 to 1-7, in the same districts as precinct 1-1. He also asked why there was a precinct with just 660 voters. He said he wouldn't object as long as we're consistent when dealing with smaller precincts in other parts of the county. No further research is needed for this precinct.

[41:54] 04-08 – Mr. Banov asked if the staff had found a polling place for what would be new precinct 4- 45 (carved out of present 4-08). He suggested using retail space in that area. Ms. Rzeszut suggested Tilden Middle School. However, Mr. Naimon noted that Tilden had moved from Old Georgetown Road to Tilden Lane and was therefore too far for voters in a 4-45. Instead he suggested the Montgomery County Conference Center, but Ms. Rzeszut said the conference center told her that there was no space available for the Board's polling place needs. Mr. Naimon recommended that the Board keep precincts 4-04 and 4-08 as they are and to revisit these precincts in two years. Mr. Banov said that if staff could not locate cheap retail space in the new 4-45, he was satisfied leaving precincts 4-04 (Parkside) and 4-08 (Garrett Park Elementary School) as is. The Board decided to keep precincts 4-04 and 4-08 as they have been

Mr. Karpinski responded that a number of individuals wrote the Board about keeping the precinct at The Promenade. The precinct 07-31 will continue to vote at the Promenade and not be merged with precinct 7-10, which votes at St. Jane Frances de Chantel Church.

Mr. Naimon indicated that he is uncomfortable with more than 4,000 voters in a middle school but is not sure if having 5000+ voters at Sherwood High School would be better. Ms. Rzeszut explained some of the pros and cons, including that many of the affected voters are in the area closer to the middle school. Ms. Dillon suggested focusing on vicinity if the facilities are relatively similar. Mr. Naimon indicated he would get over his discomfort based on Ms. Rzeszut's view that Farquhar Middle School is sufficiently large and closer to the voters.
