

Combined Provisional and Vote By Mail Canvass Minutes

2022 Primary Gubernatorial Election

The canvass began on July 21, 2022, at 10:00 a.m. and the 2022 Gubernatorial Primary Election results were certified at the meeting of Montgomery County Board of Canvassers held on August 13, 2022, at 3:00 p.m. The Certification meeting took place at the Montgomery County Board of Elections, 18753 N. Frederick Avenue, Suite 210-Board Room, Gaithersburg, Maryland 20879.

Nahid Khozeimeh, Chairwoman of the Board of Canvassers, other Board members and Legal Counsel participated virtually.

Following the certification of the 2022 Gubernatorial Primary election results, a candidate on the primary ballot filed a Petition for an official county-wide recount of votes for Democratic Party Nominee for County Executive on August 16, 2022.

The official recount was conducted from August 19, 2022, through August 22, 2022. Post recount re-certification of the election results took place on August 24, 2022, at the Montgomery County Board of Elections, 18753 N. Frederick Avenue, Suite 210—Board Room, Gaithersburg, Maryland 20879.

CANVASS MEETINGS

The canvass for 2022 Primary Gubernatorial Election took place during the period of July 21, 2022 to August 13, 2022, and included a total of 13 canvass days (for a more detailed overview of Canvass days please see attached document titled *Canvass Days Overview*).

Canvass was conducted at the Montgomery College Germantown Campus at 20200 Observation Drive, BE 151/152, Germantown, Maryland 20876 and at the Montgomery County Board of Elections, 18753 N. Frederick Avenue, Suite 210 Voting Area, Gaithersburg, Maryland 20879.

DECLARATION OF QUORUM PRESENT

The meeting of the Board of Canvassers began at 10:00 a.m. on Thursday, July 21, 2022 at the Montgomery College Germantown Campus at 20200 Observation Drive, BE 151/152, Germantown, Maryland 20876. A quorum of the Board of Canvassers was present, with a majority of the Board and at least one member of the Board of Canvassers who is a registered voter of the principal minority party present.

CONFIRMATION OF OATH

Stephanie Kim, the Deputy Clerk of the Circuit Court, administered and recorded the oath of each member of the Board of Canvassers on July 19, 2022. The Board of Canvassers included all regular and substitute members of the Board of Elections.

ANNOUNCEMENT OF OFFICERS

Election of officers occurred on July 19, 2022, and the following were elected:

- Nahid Khozeimeh was elected to serve as Chairwoman of the Board of Canvassers.
- Diane Nash Dillon was elected to serve as Vice Chairwoman of the Board of Canvassers.
- David Naimon was elected to serve as Secretary for the Board of Canvassers.

PUBLIC NOTICE OF CANVASS

Public notice of the canvass was posted on July 11, 2022 (a Media Advisory was issued and information was presented on the Montgomery County BOE website). On the first day of the canvass on July 21, 2022 and all subsequent canvass days, a quorum of the Board of Canvassers was present, with a majority of the Board and at least one member of the Board of Canvassers who is a registered voter of the principal minority party present.

Nahid Khozeimeh, Chairwoman of the Board of Canvassers, welcomed the canvassers and introduced the members of Board of Canvassers, who separately addressed canvassers, observers, and the general public.

Kevin Karpinski, the Legal Counsel to the Board of Canvassers, administered the oath for all canvass workers. Mr. Karpinski also explained in-person public observation rules of the canvass process and further presented public observation through livestreaming (with the links to the canvass schedule provided on the BOE website). Mr. Karpinski explained the rules of conduct (for canvassers, observers and visitors) and introduced the Board of Elections canvass team.

Mr. Karpinski presented, in detail, the canvass process and announced Board plans to have Board referral sessions at 1:00 p.m. and 5:00 p.m. each day of the canvass. If there were changes to the time for Board referrals due to scheduling issues, the change in time was to be posted on the BOE website and announced when the canvass commences on that date.

CANVASSING OF BALLOTS

The canvass process for 2022 Gubernatorial Primary Election took place during the period from July 21, 2022 to August 13, 2022, and included a total of 13 canvass days (for a more detailed overview of Canvass days, please see attached document titled *Canvass Days Overview*).

Canvass was conducted at two locations:

1. Montgomery College Germantown Campus at 20200 Observation Drive, BE 151/152, Germantown, Maryland 20876
2. Board of Elections, 18753 N. Frederick Avenue, Suite 210 Voting Area, Gaithersburg, Maryland 20879

2022 Gubernatorial Primary Canvas was divided in three segments - Canvass I, Canvass II and Provisional Ballots Canvass.

Canvass I was conducted solely at the Montgomery College Germantown Campus on July 21, July 22, July 23, July 25 and July 27. Canvass I included canvassing of standard mail-in ballots and web delivery ballots issued by set deadline of July 15, 2022.

Canvass II was conducted at the Montgomery College Germantown Campus in the period July 29, 2022 through August 5, 2022. Regular mail-in ballots and web delivery ballots were canvassed over the following 6 canvass days: July 29, July 30, August 1, August 2, August 3 and August 5.

Provisional Canvass was opened on July 27, 2022, at 10:00 a.m. and recessed after the opening. Provisional ballots canvass was reconvened on August 5, 2022 and continued on August 6, 2022 and August 13, 2022. It was conducted on July 27, August 5, and August 6 at the Montgomery College Germantown Campus, and on August 13 at the Board of Elections in Gaithersburg, Maryland.

RELEASE OF OFFICIAL RESULTS

Certification document announced the results from the combined vote by mail and provisional ballots canvass.

VERIFICATION OF VOTE COUNT

On August 12, 2022, the Acting Election Director McLaughlin explained that BOE staff conducted several post-election verifications and audits. The Acting Election Director informed the Board of all the steps taken as prescribed by the relevant processes.

Logic & Accuracy testing was completed and documents were submitted timely to SBE. 100% Verification was completed, and all data was transmitted to SBE and Clear Ballot.

Voting Unit and Pollbook Allocation was in conformance with SBE allocation recommendations.

Mail-In Drop Box Integrity Transportation Reports were submitted for three randomly selected Drop Box locations: Blake HS, Mid-County Community Recreation Center and Whitman HS.

BOE staff timely submitted to SBE the Election Judge Training materials, Polling Place Evaluations and Ballot Accounting forms.

As a part of the post-election audit process, BOE staff conducted Precinct Audit - which includes comparison of Pollbook check-ins to ballots cast and post-election Audit of Mail-in Ballots and Provisional Ballots.

POST ELECTION AUDITS

The Acting Election Director presented the Board of Canvassers with the Precertification Audit Report and the Clear Ballot Report for 2022 Gubernatorial Primary Election during the Board's Special Session on August 12, 2022.

The Acting Election Director informed the Board that the staff conducted a manual audit of a randomly selected 5% of all precincts, including a hand count of the number of voter authority cards from each precinct, as well as manually entering the votes for each candidate from the printout of election night results from each scanner into a spreadsheet and comparing that information with the reported results.

Staff compared the number of voters who checked in with the number of ballots cast at every voting location and investigated all discrepancies. For any location with a variance of five or more, the State Board of Elections requires a manual audit and an explanation of the variance. The audit confirmed that there were no polling places with a discrepancy outside of the allowable threshold for audit (+/- 5).

The Acting Election Director explained that a sample of accepted mail-in ballots was reviewed to determine whether the mail-in ballot was received timely and if the voter signed the oath. A sample of rejected mail-in ballots was reviewed to determine whether the voter's mail-in ballot was received timely, the required signature was provided, the required ID was provided or if the voter had voted multiple ballots.

The Acting Election Director explained that a sample of accepted in full provisional ballots and a sample of partially accepted provisional ballots were reviewed to determine whether the provisional voter was registered to vote at the time of the election, voted the ballot for the precinct in which the voter resides, provisional oath was signed, voter has not already voted and all other applicable criteria were met. Staff also reviewed a sample of rejected provisional ballots to confirm that the voter was not registered to vote at the time of the election, the voter returned a voted mail-in ballot or already voted, or the voter's ballot was rejected for another valid reason.

The Acting Election Director explained that all ballot images from Early Voting, Election Day and the Canvasses were sent to Clear Ballot, a third-party, for re-tabulation. The vendor produced reports comparing precinct-level results from the voting system against the precinct-level results from the re-tabulation, and these reports show any differences between the two sets of results. SBE confirmed on July 28, 2022, that for early voting and Election Day, Clear Ballot tabulated the same number of ballots as the voting system, and any differences in the results were within the State's threshold to verify the accuracy of the voting system. On August 12, 2022, SBE confirmed that for the provisional and vote by mail canvasses, Clear Ballot also tabulated the same number of ballots as the voting system, and any differences in the results were within the State's threshold to verify the accuracy of the voting system.

CERTIFICATION OF ELECTION RESULTS

The Board of Canvassers met on August 13, 2022, at 3:00 p.m. in the Board Room of the Montgomery County Board of Elections, 18753 N. Frederick Avenue, Gaithersburg, Maryland 20879 to certify the 2022 Gubernatorial Primary Election results. Present in-person was David Naimon, Secretary of the Board of Canvassers. Nahid Khozeimeh, Chairwoman of the Board of Canvassers and other Board members and the Board's Legal Counsel participated virtually. There was a quorum of the Board of Canvassers, with a majority of the Board and at least one member of the Board of Canvassers who is a registered voter of the principal minority party present.
