The 2022 Gubernatorial Primary Election is quickly approaching. Election Worker recruiting is in full swing and there is still time to sign up to serve. Election Workers serve a vital role in the electoral process by ensuring the integrity of the election. We appreciate your continued support and service.

Important Training Update! Beginning May 28th, we **waived** the requirement to complete the Part II-Online Training prior to taking the In-Person training. If you have completed the Part I-Quiz, you may contact your Recruiter and go directly to In-Person training. The June training calendar is available now through your EJ Connection account. Election Worker training is required to participate.

Election Day Assignments If you have successfully completed the required training for your position, you will receive an Election Day service assignment. That assignment will be released on June 28th via your EJ Connection account. Election Day is July 19th, and the pre-election set-up meeting is the evening of July 18th. All election workers assigned to a polling precinct are required to attend.

Early Voting Assignments Early Voting assignments will be released on June 16th via your EJ Connection account. Early Voting is conducted from July 7th through July 14th and the pre-early voting set-up meeting is July 6th at your assigned Early Voting center. Election Workers assigned to work the first day of Early Voting are required to attend. Please note that if you signed up to serve and you don't see your assignments, please be patient. The Early Voting recruiters will be working throughout the month of June to staff all the locations.

Are you interested in a leadership role as Chief Judge or Roamer on Election Day? If you have good organizational and communication skills and an interest in either of these positions, notify your Recruiter. To be a Chief, it is recommended that you have prior experience as a VOP judge and to be a Roamer prior experience as a Chief is required. See position descriptions at www.777vote.org

Renew your application for 2022. Reminder, under Maryland law a new election application is required for each election cycle. You may log into EJ Connection to **renew** your application, confirm your availability, and update your contact information. If you need assistance renewing your application or gaining access to your account, please contact the recruitment office. If you make changes to your name, address, or party affiliation (which affects your voter registration) you will be asked to print, sign, and submit an update form. **We must receive your signed form to process your application;** fax it to 240-777-8578 or scan and email it to election.judge@montgomerycountymd.gov.

Official Promotion Rules:

Entry tickets are available in training classes, or you can contact your Recruiter. Drop the entry ticket into the “Promotion Box” located in your training class. There is no limit to the number of referrals you may submit.
2. This promotion will be held from March 28, 2022 until training classes end for the General Election.
3. To qualify to win, both “Pals” listed on the entry ticket must serve as Election Workers for the Gubernatorial Primary Election on July 19, 2022 or the General Election on November 8, 2022. The “Pal” who is referred must be new to the Election Worker Program and has never served as an Election Worker. Both “Pals” must be in good standing with the Election Worker Program.
4. The drawing will be held after the Primary and General Elections in December 2022 at the Board of Elections. The first entry ticket drawn for which both “Pals” qualify will be the winners!!

I'm working on Election Day when do I vote? Election Workers are asked to vote either by Mail-in ballot or during the Early Voting period at a time when you are not assigned to serve. Complete, sign, and submit a Mail-in ballot application as soon as possible. Applications are being mailed by the State Board of Election to every registered voter beginning in February. The Mail-In ballot office will process your application and send you a ballot. Your voted ballot may be returned to the Board of Elections, mailed with a postmark by the Postal Service dated by Election Day or dropped in one of the designated Drop-Boxes by 8:00 pm on Election Day. Full day Election Workers who are **not** assigned to work in their voting precinct on Election Day who have not voted and still wish to vote must vote a provisional ballot in their work precinct, since they will be unable to leave and go to their voting precinct.

Training

A complete overview of the required training to be an Election Worker is located on our website at www.777vote.org Completion of training is required by law to serve as an Election Worker.

Part I – Quiz

The Quiz includes reading portions of the Election Judge manual, looking at training videos and taking a Quiz. The Quiz provides basic information about serving as an Election Worker.



Part II – Online Training

This portion of training is waived as a requirement for the Primary Election. It is still highly recommended that you take it prior to the election. The Trainers are incorporating most of the material into the In-Person training class



Part III – In-Person Training Class

The In-Person Training class allows Election Workers to practice with actual election equipment. Workers will receive instruction on the procedures and responsibilities of the precinct team and their specific position. You will complete practice exercises and forms; role play with the voting equipment and simulate setting up and breaking down a polling place. The online training will be used to enhance the experience of practicing on the equipment in the training class.

Scheduling In-Person Training Classes

Most Election Workers, regardless of prior service, will attend a new In-Person training class. Once you have completed Part 1 of training your Recruiter will provide instructions on how to schedule your In-Person Training class. You will use our online scheduling feature on EJ Connection to select a class that best matches your schedule. Training will be offered weekdays, evenings and weekends and will be posted in EJ Connection. Classes will be held at the following offsite locations:

Working Early Voting

If you wish to serve at one of the 14 Early Voting Centers, you will be **required** to serve on Election Day and a minimum of two Early Voting days. There is no additional training required to serve during Early Voting unless the position requires it. New Early Voting Centers for 2022 are White Oak Community Center (EV-12), Nancy H. Dacek North Potomac Community Recreation Center (EV-13), and Bauer Drive Community Recreation Center (EV-14). Location addresses can be found at www.777vote.org. Permission Slip Requirement

Election Workers under 18 years old must submit a Permission Slip signed by their parent or guardian to serve (Signature must be handwritten, no electronic signatures accepted). The Permission Slip is available on the EJ Dashboard. The Permission Slip must be received in the office prior to the scheduling of your training. If you are 16 or 17 years old, you must meet the following requirements to participate by visiting our website www.777vote.org:

- **Register to Vote:** select *Online Voter Registration* tab and follow the prompts.
- **Submit an Election Worker application:** select *Election Workers* tab then *Getting Started*
- **Submit a Permission Slip:** select *Election Workers, Qualifications*, select the *Permission Slip* link, have your parents fill it out. Submit the form by mail, fax, or email (scan and attach to email).

Bilingual Election Workers are needed

Due to the requirements of Section 203 of the *1975 Voting Rights Act*, workers with Spanish speaking fluency are needed in every precinct. We are also looking for workers that speak Chinese, French, Korean and Vietnamese. Please list all languages that you speak fluently on your application.
