Election Judge stipend payment:

The payments of the stipend for the Election Judges are expected to be sent out as planned so that it arrives no later than six weeks after the November 3, 2020 General Election. In addition to the stipend for the various positions of Chief, Voting Operations Judge, etc., the Board agreed to provide a Covid-19/Hazard payment as follows:

- Full day serving the Voting Public at a Voting Center during Early Voting or Election Day at \$100.00 per day/diem. A full day was defined as 6:00 A.M. to 10:00 P.M. or until closing.
- 2. Part-time position serving the Voting Public at a Early Voting Center or Voting Center as an Election Judge between five to nine hours at \$50.00 per day/diem.
- Canvass Election Judges assigned to canvass the Vote by Mail Canvass receiving and opening all Vote by Mail and Provisional Ballots are to receive \$20.00 per day/diem.

The Board of Elections members and staff are deeply grateful for the commitment you have shown to the election process and applaud all participants for their service to the Montgomery County Voters.
