#### **New Election Workers**

New election workers or those that did not work the Primary Election must have a completed **2016 Application** on file and will need to pass the Stage I Training Quiz.

To make the process easier for you and to cut down on the time it takes for us to receive and process applications, we encourage you to submit your application online. You will receive a username and password once your application is processed.

Note: If your application has name, address or party affiliation changes (which affect your voter registration) you will see a message directing you to print, sign and submit an Update Form. Click on the *EJ Update Form* button on the dashboard under **ACTION** to open and print the pre-filled form. If you forget to print the form at that time, you can log back into the dashboard to print it. We <u>must</u> receive your signed form to process your application; fax it to 240-777-8578 or scan and email it to <u>election.judge@montgomerycountymd.gov</u>.

#### **Training**

Training consists of two stages – Stage I, an online training quiz, and Stage II, an in-person, hands-on training class. Once you have passed the training quiz, your Recruiter will provide you with information to schedule your hands-on training.

#### Stage I - Online Training Quiz

This portion of the training is required and has been designed to complement the hands-on training and enhance your preparation for Election Day.

#### **Follow these steps:**

- 1) Click on this hyperlink: www.777vote.org
- 2) Click on "Election Workers", on the left side of the screen, to expand the list of choices.
- 3) Click on "*EJ Connection*" and enter your Username and Password/VID (as provided by BOE).

#### Once you are logged in, follow these steps

- 1) Click on "*Training Materials*" in the "Resources" section on the right side of the screen to open the Election Judge Manual.
- 2) Click on and read Chapters 1 through 4.
- 3) Click on and watch the video "Assisting Voters with Disabilities".

#### When you feel ready to take the quiz

- 1) Log back into the Election Worker Program.
- 2) Click on "Training Materials"
- 3) Click on "2016 Election Worker Training Quiz" to open the quiz.
- 4) Follow the instructions for taking the guiz.
- 5) To keep a copy of your answers, print the quiz <u>before</u> you hit "Submit."
- 6) When finished, click "Submit" to send the quiz to the Board of Elections. Please press the Submit button only once.

#### Stage II - Hands-On Training

#### **Scheduling**

Hands-on training for the General Election is **required** for all judges, regardless of whether they worked the Primary Election or not. Most classes will be held at our Gaithersburg office. Classes will also be held offsite at other locations in the county if possible. You must pass the hands-on training to be eligible to work. **Those completing training early have a better chance of being able to work in their voting precinct and during early voting.** 

#### **Class Formats**

- Returning Judges Worked in the April 26<sup>th</sup> Primary
   This course is a full hands-on training which includes scenarios and exercises at each station and on the voting equipment. It provides an opportunity for judges who have worked previous elections to practice the tasks for their assigned position and sharpen their skills.
- New Judges Brand new or did not work the April 26<sup>th</sup> Primary

  This course is a combination of lecture and hands-on training to prepare new
  judges and returning judges who did not serve in the April 26<sup>th</sup> Primary. Students
  will receive instruction on the procedures and responsibilities of the precinct team
  and their specific position. Students will work individually and in pairs to complete
  practice exercises and forms and to role play with the voting equipment including
  setting up and dismantling a voting precinct.

We strongly encourage you to review each chapter of the Election Judge Manual, available online, prior to attending class.

**SILVER SPRING, MD** – EAC Chairman Thomas Hicks announced September 19, 2016 the results of an Election Worker Best Practices Competition. The EAC honored five winners for their excellence in recruiting, training, and retaining election workers.

The EAC's Election Worker Best Practices Competition was a national contest that sought to identify and honor the best poll worker management practices from around the country. Election officials submitted their best practices in the form of videos, websites, training guides, and narratives to the EAC. The EAC then facilitated a review process in which a group of seven state and local election officials judged the entries based on five criteria: (1) innovativeness, (2) effectiveness, (3) sustainability, (4) cost effectiveness, and (5) potential for replication. The EAC received many excellent entries, but five stood out above the rest.

The winners of the EAC Election Worker Best Practices Competition are:

<u>The Precinct Performance Report (Montgomery County Maryland)</u>: a pragmatic assessment and adjustment program where the performance of individual precincts is used to shape the following year's trainings and resource allocation.

<u>Champions of Democracy (Franklin County, Ohio)</u>: an innovative campaign that recruits and trains poll workers at local businesses.

<u>Election Official Resource Portal (New Hanover County, North Carolina)</u>: an online portal that provides an up-to-date centralized clearinghouse of poll worker duties and responsibilities.

<u>Practice Makes Perfect Lab (Brevard County, Florida)</u>: a cutting edge and replicable hands-on and self-paced training program that has trained over 1,700 poll workers.

Youth at the Booth (YATB) and Partners in Democracy (Hamilton County, Ohio): YATB is an initiative that pairs young and old poll workers together to create a comprehensive staff of poll workers. Partners in Democracy is an initiative that encourages businesses and agencies to give their employees a "day off for democracy" where they may work as poll workers.

#### **Position Descriptions**

#### Chief Judge (CHF) or CHF-C

Chief Judges (CHF) serve as the precinct supervisors, providing oversight of the operation of the precinct in accordance with Maryland law. Ensure a calm, pleasant voting day experience for voters while making certain all procedures are followed and the integrity of the election is preserved. Coordinate and supervise pre-election, Election Day, and post-election activities. Review and certify precinct reports and documentation.

#### Voting Operations Judge (VOP) or VOP-C, Spanish-speaking VOP (SPN)

Voting Operations Judges perform the duties associated with each functional area in the voting precinct on a rotating basis throughout the election day. The number of VOPs assigned to each precinct varies based on anticipated turnout. A Spanish-speaking VOP is assigned to each precinct to voters as requested.

#### Opening (OPN), Voting Operations (VOP-A and VOP-B) Judges

Opening, VOP-A and VOP-B judges perform the same duties as VOP Judges while working their assigned hours. These are part time positions.

#### **Voting Operations Judge – Driver (VOP-D)**

Voting Operations Judge - Driver performs all of the same duties as other VOP judges during the day. When the polls are officially closed, the VOP-D will transport the memory stick with the unofficial results and the ballots to either a satellite location or the Board of Elections.

#### **Voting Operations Judge - Provisional (VOP-P)**

Voting Operations Judge - Provisional handles the processing provisional voters from check-in through casting their ballot at the provisional station. The VOP-P will check-in the voter, instruct the voter in how to complete the Provisional Ballot Application, issue the provisional ballot and ensure the voter casts their ballot in the locked provisional ballot bag.

#### Closing Judge (CLS) or CLS-C

Closing Judges work part time as an additional resource during evening voting hours. They provide relief for VOP judges at check-in and the voting areas. When the precinct closes, Closing Judges are responsible for assisting the Chief Judges with closing down the voting equipment and then delivering the critical materials to the Board of Elections election night.

#### **Greeter (GRT)**

Greeters direct voters to the voting precinct within the building. Greeters are assigned to a limited number of precincts per election.

#### **Election Worker Payments**

It is very important for all election workers to sign-in when coming to training, a Chief Judge Briefing, the Monday Night pre-election meeting, each day of early voting and on Election Day. In order to ensure everyone is paid correctly, we rely on these documents as verification of service. It is the Chief Judge's and Site Manager's responsibility to certify that everyone has signed in and worked their assigned hours. If you come in or have to leave early or stay late; please make sure the times are noted on the payroll roster.

In order to be paid for working as an election worker, you must provide your full social security number. If you did not put your information on your application, please call your Recruiter and give them your social security number. The deadline for us to receive your information is Monday, November 14, 2016. After that date, we will be unable to update your information.

We really appreciate all of you who have chosen to donate your service to Montgomery County by not requesting payment of the stipend. Thank you!

#### **State and County Government Employees**

State of Maryland and Montgomery County Government (MCG) employees can receive up to 8 hours of administrative leave for serving as election workers on Election Day. Administrative leave cannot be used for working early voting. Employees must get their supervisor's approval in advance to receive the administrative leave. State employees must also complete and submit a State Employee Election Judge Service Form after the election.

**Note:** MCG employees who use administrative leave on Election Day will have the service portion of their stipend reduced by 20%, under a directive of the CAO to comply with ethics requirements. Employees using annual or personal leave will receive their full Election Day service stipend.

Send your form by mail, email or fax.

#### **Your Vote**

<u>All</u> election workers are asked to vote either by absentee ballot or during the early voting period. Chief and Voting Operation judges who are **not** assigned to work in their voting precinct <u>must</u> vote by absentee ballot or during early voting (or cast a provisional ballot in their work precinct), since they will be unable to go to their voting precinct on Election Day.

Need an Absentee Ballot? Fill out an <u>Absentee Ballot Application</u> at training or in our main office.

The Absentee office will send you the appropriate ballot to vote. Your ballot must be returned to the office or postmarked (by the Postal Service) by Election Day. <u>Absentee ballots cannot be left at the polls for return to BOE;</u> this is prohibited by Maryland law.
