We're hiring temporary employees for the 2018 elections. Two job announcements for temporary employees have been posted on the **Montgomery County Government Human Resources website**.

The **Election Aide I** and **Election Aide II** positions are used to fill temporary positions in our agency. We are looking for individuals to work a variety of jobs in every facet of the election planning process.

Positions are open in voter registration, absentee/nursing home, warehouse, election worker recruitment and training, and IT. Most positions are full time. Applicants bilingual in Spanish are encouraged to apply.

Election Worker Stipend Rates Change

Effective July 3, 2017, the stipend rates for election workers changed. Election Workers receive payment, based on their assigned position, for successfully completing all required training and working on Election Day. *Workers who complete training but do not serve will not be paid.*

New rates:

Chief Judges - \$250 + \$50 for training = \$300

Closing Judges - \$100 + \$30 for training = \$130

Voting Operation Judges - \$180 + \$30 for training = \$210

Part time VOP Judges - \$90/shift + \$30 for training = \$120

Did you know?

Montgomery County's Nursing Home and Assisted Living Program

The Nursing Home and Assisted Living Program is a Maryland statewide initiative mandated by State law which affords residents of assisted living or nursing facilities the opportunity to access the voting process without fear of outside influences or intimidation.

As part of absentee voting, local boards of elections are required to offer voting assistance to all nursing homes and assisted living facilities within their jurisdiction that have at least 50 residents. In Montgomery County, approximately 50 organizations participate in this absentee program.

Visits are scheduled with facility administrators and teams are assigned facility visits where temporary polling places are setup. Administrators reach out to their residents and encourage them to take advantage of the convenience of voting at the facility. The program is especially helpful to residents who do not have the ability to travel to their designated precinct. Once voting at the center is completed, all ballots are returned to the local boards of elections and are counted along with other absentee ballots during the canvassing period.
