A personalized sample ballot is being mailed to all registered voters, with the information needed to vote in the 2018 Gubernatorial Election. Don't mistake it for junk mail - the sample ballot is an 8 ½ x 11 booklet and is the official sample ballot from the Montgomery County Board of Elections. It contains information on Early Voting locations and lists your Election Day polling place on the back cover.

## **Training Updates**

### **Voters to Receive a Three-Page Ballot**

For the general election, Montgomery County voters will vote on a three-page ballot. As a result, the way we send ballots to each polling place and the Monday night set-up process are changing. For this election, ballots will be packed inside the scanning units in specially labeled cardboard boxes and on the top shelf inside the Black Cart.

Election teams will need to remove the boxes of ballots from the scanning units BEFORE rolling the units out of the Black Transfer Cart. This is to prevent the scanning units from falling over and hurting you. **A new instruction sheet has been developed, showing each step of the process ([click here to view](#))**. Any additional information will be provided to Chief Judges in the Quick Start toolkit and at the Chief Briefings.

### **Ballot Preparations**

Recently, we began receiving shipments of ballots. During our quality control checks, we discovered that some ballots were incorrectly perforated. Because of this, ballots tear along the tic marks that are read by the scanner making the ballots unreadable. In addition, ragged edges and an extra build-up of paper dust can cause scanning units to jam. To reduce the number of spoiled ballots and scanning unit jams and to prevent long lines at the ballot issuing table we have made some changes. These changes include:

- BOE removing the ballot stubs from the most damaged ballot styles prior to sending them to the polling place. These ballots will have a colored slip sheet between each quantity of 50 ballots.
- Election workers removing stubs from all other ballots on Monday night, using the provided cutting tool. Chiefs will be shown how to remove the ballot stubs at the Chief Briefings. A clean edge is vital!

**Ballot Preparations - continued**

- Election workers pre-stuffing privacy sleeves with each page of the ballot Monday night. We recommend preparing at least 50 privacy sleeves Monday night, for the morning rush of voters. Be sure to lock all ballots inside the Black Cart at the end of the set-up meeting.

We hope that these measures will alleviate the problem. Unfortunately, it is not possible to reprint all the ballots in time for the election.

**Scheduling Training**

Call us on 240-777-8533 or log into the Election Judge (EJ) Connection online schedule your hands-on training for the General Election. All classes will be held at our Gaithersburg office. Go to EJ Connection for maps & directions.

**If you worked the Primary election**

Election workers who trained **and** worked the Primary Election do not have to re-apply or re-take the Stage I Training Quiz. You just need to log-in and schedule your Stage II Hands-on Training refresher class. **Note:** If you indicated that you were not going to be able to work the general election, but now you can work, you will need to notify your recruiter to update your availability, prior to scheduling training.

**All Other Election Workers**

New election workers or those that did not work the Primary Election must have a completed **2018 Application** on file and will need to pass the Stage I Training Quiz; prior to scheduling the hands-on training. If you haven't done so already, please renew your application online today. Under Maryland law a new or updated application is required for each election cycle. See more information on page 7.

**Practice Training Sessions**

We will offer several practice training sessions for judges who have completed their required training and want more practice. During the sessions, students can practice using the equipment and ask questions of the trainers. The sessions do not count toward completion of the required hands-on class. We highly recommend that all judges attend at least one refresher/practice session. It is not necessary to register in advance. See the schedule on page 9 and the EJ Connection (Walk-in Training).

**Election Day Assignments**

Remember that you must complete all required training to be eligible to serve. To ensure that we have enough workers assigned to every precinct, we ask that you complete your training as soon as possible; *especially if you would like to work in your own voting precinct*. You will get an email when you have been assigned. Each precinct has a limited number of positions. Workers who wait to complete their training will be assigned to precincts closest to their homes, that have vacancies or asked to serve as a Standby Worker.

**Working Early Voting**

If you are interested in working at one of the eleven Early Voting centers between October 25 and November 1, 2018, follow the steps below:

1. Schedule your election day hands-on training as soon as possible;
2. Notify Jessica Jones by email that you are interested in working early voting ([Jessica.jones@montgomerycountymd.gov](mailto:Jessica.jones@montgomerycountymd.gov));
3. Complete your election day hands-on training;
4. Schedule and complete the additional early voting training class;
5. When you have finished early voting training you may submit your availability to your assigned early voting recruiter;
6. Receive early voting assignment information.

You must agree to work election day to be eligible to work early voting.

**Your Vote**

Election workers are asked to vote either by absentee ballot or during the early voting period. Chief and Voting Operation judges who are **not** assigned to work in their voting precinct must vote by absentee ballot or during early voting (or cast a provisional ballot in their work precinct), since they will be unable to go to their voting precinct on Election Day.

**Absentee Ballot** – Complete, sign and submit an [Absentee Ballot Application](#) as soon as possible. Forms available at training. The absentee office will send you a ballot to vote. Your ballot must be returned to the office or postmarked (by the Postal Service) by Election Day. Absentee ballots cannot be cast at the polls.

**Early Voting** - Vote at one of the county's early voting centers between Thursday October 25 and Thursday November 1, 2018. Voting hours are 10:00 a.m. to 8:00 p.m. For more information on the 11 early voting locations, go to [www.777vote.org](http://www.777vote.org).

**Keeping us informed** – Please keep your voter registration and contact information current. Update your personal information online in the EJ Connection portal. Click on ***Update Personal Data*** to enter your information. Phone numbers and email addresses will only be released to the Chief Judges for election related use.

**Future Vote Student Aides** - School-age students, grades 6-12, can serve as student election aides. The program's intent is to educate, strengthen and increase ties related to civic participation. Interested parents/guardians register their student(s) [online](#) (use this link). **All student election aides and a parent or guardian must attend a 1-hour mandatory training to participate; even returning Future Vote volunteers. Students 16 years old and registered to vote may work as an election worker for payment or SSL credits.

**How to Renew your Application**

Though you are already registered in our system, you need to confirm your information and electronically sign or affirm the data on file for this election. Follow the instructions below. Let us know if you need help logging in or completing the application. (Note: Firefox is not compatible with our online program, please use a different browser.)

1. Go to the Montgomery County, Board of Elections website [www.777vote.org](http://www.777vote.org) and click on **Election Workers** (in the 2<sup>nd</sup> row of boxes). Next click on **Election Judge (EJ) Connection** (Returning workers) to open the log-in page.
2. Enter your User Name and Password (previously provided by BOE) to open the Election Worker Dashboard. To avoid login errors do not copy and paste; type in the log-in information.
3. Click on **Application Renewal** in the **ACTION** box to open the application screen. Confirm or enter the required information in each section and click NEXT to navigate to the next page. Review the Summary of your information and if everything is correct click NEXT to continue. Click PREVIOUS to go back to change your responses. Do not use the back button on your browser.
4. In Section F, read the Affirmation statement and click on the circle to confirm your agreement. Click on **Submit**. Congratulations, you're finished! You will receive a "thank you" message immediately on the screen and an email confirmation within a few minutes. The next step is to complete your training.

Note: If you have changes to your name, address or party affiliation (which affect your voter registration) you will see a message directing you to print, sign and submit an Update Form. Click on the **Confirmation Form** button to open and print the pre-filled form. **We must receive your signed form to process your application;** fax it to 240-777-8578 or scan and email it to [election.judge@montgomerycountymd.gov](mailto:election.judge@montgomerycountymd.gov).
