MILITARY RETIREE PROPERTY TAX CREDITS (Bill 42-16) **TAX YEAR BEGINNING JULY 1, 2025**

This tax credit is available for properties with assessments of \$550,000 or less, as of the time of application.

Applications for 2019 and afterward will be due on April 1st of each year.

**To receive the tax credit beginning Levy Year 2025, the Military Retiree's surviving spouse must be at least 65 years old. The Military Retiree must have been retired from one of the services listed below. The Surviving Spouse must provide a copy of (1) the Military Retiree's death certificate; (2) the Military Retiree's proof that he or she was actually retired from one of the services below (this credit is not available for Surviving Spouses of Veterans if the deceased Veteran was not actually retired from an eligible service listed below).**
