# **News You Can Use To:**

Assess Your Risk for Alzheimer's Disease: People who are concerned about memory function can now utilize an updated, easy-to-use screening tool known as AD8 (Ascertain Dementia 8) to help identify signs of dementia or mild cognitive impairment. The evidence-based screening tool asks users eight brief questions related to memory, orientation, judgment, and function and can detect early cognitive changes associated with several brain-related illnesses, including Alzheimer's disease, vascular dementia, and Lewy body dementia. AD8 is offered in several languages and can be self-administered or given by family members, loved ones, health care providers, and caregivers. In addition, Maryland Access Point (MAP) counselors across the state have been trained on how to administer the helpful tool.
